Mr. Poore called the meeting to order and Councilman Fred H. Bratcher gave the invocation.

On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to approve the minutes from the August 4, 1981 meeting as mailed.

Mr. Dan Rhodes presented Ordinance #69 (Rules & Regulations of purchases after May 15) for second reading. On the motion of Mr. Rhodes, seconded by Mr. Wright, Council voted 4 in favor and 1 against adopting Ordinance #69 on second reading. Motion passed by majority vote. Mr. Bratcher voted against the motion.

Dr. Don Garrison, President of Tri-County Technical College, asked Council to sign a letter of intent to ~~commit~~ ^{provide} financial support for future construction of a Learning Resource Center/~~Administration~~ Building on the campus at Tri-County with the use of funds generated by the three (3) mills now being assessed for the College. On the motion of Mr. Kinley, seconded by Mr. Rhodes, Council voted unanimously to sign the letter.

Mr. Robert King asked Council to fund \$621.18 toward the purchase of 3 pair of anti-shock trousers for a joint purchase with EMS Council. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to transfer funds from Account #910 Contingency Fund for the purchase of the request.

Mr. King advised Council that Pickens County had contacted him concerning changes in plans for Oconee County if there should be a nuclear attack at the Oconee plant. Part of the people that would be sent out of Oconee County to Townville and Anderson County they would like to send to Georgia. Pickens County would like to route part of the people from lower part of Pickens into Pendleton. On the motion of Mr. Bratcher, seconded by Mr. Hooper, Council voted unanimously to grant permission to transfer these people.

Mr. Watson read a letter for the County Assessor requesting the use of the funds set up in the salary account for permanent positions for temporary hired help. On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to give the Assessor permission for his request.

On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to

transfer all expense accounts (County Council, Supervisor and Purchasing Agent) into the salary account.

Mr. Ben Blakley told County Council that he resents the way the last meeting was handled. He felt that the meeting was out of order instead of him being out of order and he was rudely stopped from speaking by members of County Council. He thinks the \$350 expense account is a joke and the \$600 trip to Myrtle Beach is a steal. He stated County Council was not doing a good job.

On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to adjourn at 7:45 p.m.
