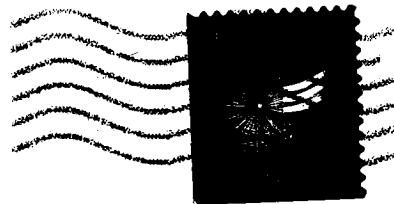
DEAR PUBLIC OFFICIAL,
