Trump EPA Pick Won't Vow To Recuse Himself In Agency Suits

Oklahoma Attorney General Scott Pruitt, President-elect Donald Trump's pick to lead the U.S. Environmental Protection Agency, declined to say Wednesday whether he'd recuse himself from several pending lawsuits he filed against the agency if he is confirmed, instead leaving the matter up to the EPA's ethics counsel.

13 States Sue To Stop Coal Mining Stream Protection Rules

Thirteen states sued the U.S. Department of the Interior in D.C. federal court on Tuesday, alleging that federal rules finalized in December aimed at minimizing harm to surface and groundwater from coal mining operations violated the states' ability to regulate mining within their borders.

2nd Circ. Restores EPA's Water Transfer Exemption Rule

A divided Second Circuit panel on Wednesday revived a U.S. Environmental Protection Agency rule exempting some water transfers from Clean Water Act review, saying ambiguity within the law means the agency must be given latitude for its own interpretation of the statute.

Enviros Take Bid To Join BLM Auction Fight To 10th Circ.

Environmental groups on Tuesday appealed to the Tenth Circuit a New Mexico federal judge's refusal to let them intervene in an oil and gas industry group's suit accusing the U.S. Bureau of Land Management of illegally failing to hold oil and gas lease auctions.

Trenk DiPasquale Can't Escape Suit From NJ Water Agency

Trenk DiPasquale Della Fera & Sodono PC fell short Wednesday in escaping a lawsuit from a defunct Newark, New Jersey, water agency when a New Jersey federal bankruptcy judge said an attorney was qualified to provide an affidavit stating that the firm deviated from professional standards in representing the organization.

NJ High Court Says Towns Must Meet Past Housing Needs

New Jersey towns must provide enough affordable housing to meet the need generated by low-income households that formed during a 16-year gap in which the state didn't update municipalities' obligations under the Fair Housing Act, the state Supreme Court ruled Thursday.

States Urge 5th Circ. To Affirm OT Rule Block

Nevada, Texas and 19 other states urged the Fifth Circuit on Tuesday to affirm an injunction blocking a recent revision to the Department of Labor's overtime rule, saying the tweaks would cause "irreparable harm on a massive scale" if they took effect.

DOL Says Fiduciary Rule Can Discourage Class Waivers

The U.S. Department of Labor told a Minnesota federal judge Tuesday that it can legally restrict an exception contained in its so-called fiduciary rule to advisers who don't prohibit clients from filing class actions, asking the judge to reject a financial planning group's challenge to the provision.

Biz Groups That Defeated DOL Rule Win Fees

A federal judge in Texas on Wednesday awarded about \$330,000 in attorneys' fees and expenses to a handful of business groups that led a successful challenge of the U.S. Department of Labor's so-called persuader rule, which expanded employers' disclosure requirements related to union-organizing campaigns.

The U.S. Department of Homeland Security on Wednesday proposed rules that would expand security and privacy requirements for contractors, a move that's part of the agency's efforts to safeguard sensitive government information.

US Loosens Regs On Exports To India With Military Uses

The U.S. Department of Commerce's Bureau of Industry and Security announced Wednesday that it is loosening restrictions on exports of goods with potential military uses to India, under a strategic partnership agreement between the two nations announced in 2010.

Bill To Reduce Corporate Tax Rate Introduced By Pa. Rep.

Pennsylvania state Rep. Jason Ortity announced on Wednesday that he had reintroduced legislation to gradually reduce Pennsylvania's corporate net income tax, which is currently the second-highest in the country.

Kimberly-Clark Can't Use Tax Compact For \$3.2M Mich. Refund

A Michigan appeals court has unanimously denied Wisconsin-based global manufacturing giant Kimberly-Clark Corp.'s bid for a \$3.2 million tax refund from the state Department of Treasury, agreeing with a lower court that the company can't use the Multistate Tax Compact to calculate income in the state.

Puerto Rico Reaches Deal On Pension Bond Payments

Holders of bonds issued by Puerto Rico's largest public pension fund reached a deal to recoup some of the money that the beleaguered territory diverted from the fund, according to a stipulation and order filed on Tuesday in Puerto Rico federal court.

IMMIGRATION

DOJ Backs Bush Official On Post-9/11 Detention Policy

The federal government defended former U.S. Attorney General John Ashcroft's controversial "hold until cleared" policy for immigrants detained following the Sept. 11 terror attacks in oral arguments at the U.S. Supreme Court Wednesday, saying the Bush administration official's cautious approach didn't violate clearly established civil rights.

TELECOMMUNICATIONS

FCC Auction Clears \$10B Target, Triggering Spectrum Transfer

A forward auction to reallocate spectrum licenses from broadcasters to wireless providers cleared its \$10 billion clearing target Wednesday, setting the stage to transfer 84 MHz of broadcast spectrum for wireless broadband use and the development of new wireless technology.

GOP Lawmaker Takes Aim At FCC Station Reporting Rule

The Republican head of House Energy and Commerce's Communications and Technology Subcommittee introduced a bill Tuesday that would forcibly revoke a Federal Communications Commission ownership reporting requirement for noncommercial educational TV station board members, blasting the requirement as "onerous" and a threat to privacy.

CBS Presses FCC To Restore Ownership Cap Exception

CBS Corp. wants the Federal Communications Commission to reinstate posthaste a break given to UHF station owners on media ownership cap rules, arguing Tuesday that the agency nixed the exception without “a shred of evidence” of public harm.

[Inmate Call Cos. Urge DC Circ. To Wait On Rate Cap Review](#)

Inmate calling service providers on Tuesday urged the D.C. Circuit to delay its review of rate caps imposed on the companies by the Federal Communications Commission in August, in anticipation of a reversal of the policy under an incoming Republican-majority commission.

[Comcast Subscribers Get HBO, ESPN Access Via PlayStation](#)

The head of the Federal Communications Commission's Enforcement Bureau praised Comcast on Tuesday for finally allowing subscribers to access HBO Go and WatchESPN TV Everywhere via PlayStation game consoles, following discussions with the agency.
