Tony Blair apologizes for Iraq War 'mistakes'

LONDON Britain's former Prime Minister Tony Blair has apologized for "mistakes" made in the U.S.-led invasion of Iraq in 2003.

Blair also said there are "elements of truth" in claims that the invasion was the main cause of the rise of the Islamic State group, in an interview with CNN's Fareed Zakaria that was broadcast Sunday.

Britain and the United States under the George W. Bush administration attacked Iraq fol-

lowing a belief, based on intelligence, that Saddam Hussein's regime had weapons of mass destruction. No major weapons of mass destruction were found.

Speaking to CNN, Blair said, "I can say that I apologize for the fact that the intelligence we received was wrong because, even though he (Saddam) had used chemical weapons extensively against his own people, against others, the program in the form that we thought it was did not exist in the way that we thought."

By the time the war officially ended on Dec. 15, 2011, more than

4,000 U.S. troops and 179 British servicemen had died and more than 100,000 Iraqi civilians were killed, according to the web-

site Iraq Body Count.

Blair also apologized "for some of the mistakes in planning and, certainly, our mistake in our understanding of what would happen once you removed 'the regime.'"

But he did not apologize for the Iraq War itself, adding, "I find it hard to apologize for removing Saddam. I think, even from today in 2015, it is better that he's not there than that he is there."

The Islamic State, also known as ISIS or ISIL, which controls vast swaths of Iraq and Syria, was formed in April 2013 after growing out of al-Qaeda in Iraq.

Speaking of the Islamic State, Blair told CNN, "Of course, you can't say that those of us who removed Saddam in 2003 bear no responsibility for the situation in 2015. But it's important also to realize, one, that the Arab Spring which began in 2011 would also have had its impact on Iraq today, and two, ISIS actually came to prominence from a base in Syria and not in Iraq."

More than 3,000 U.S. troops are currently in Iraq, training and advising government forces.

The interview is part of a larger CNN special on Iraq airing at 9 p.m. ET Monday.

Blair Says War in Iraq Helped Give Rise to ISIS

LONDON Tony Blair, the former British prime minister, suggested on Sunday that the United States-led invasion of Iraq in 2003, which removed Saddam Hussein from power, helped give rise to the Islamic State, even as he said it was "hard to apologize for removing Saddam."

Mr. Blair, whose decision to involve Britain in the military mission made him deeply unpopular

at home, told CNN that "there are elements of truth" to the view that the war in Iraq helped

pave the way for the Islamic State.

The militant group emerged as an offshoot of al-Qaeda in Iraq, which fought the American

presence there, before separating from the organization. It now controls vast swathes of territory in Iraq and Syria, and is also known as ISIS or ISIL.

Mr. Blair apologized, as he has done before, for what he called mistakes based on what turned out to be false information about the presence of weapons of mass destruction in Iraq.

"I apologize for the fact that the intelligence we received was wrong," he said, adding that he apologized for "some of the mistakes in planning and, certainly,

Offering an apology as an inquiry into the U.S.-led invasion is set to be released.

Our mistake in our understanding of what would happen once you removed the regime."

His office denied that the interview was intended to "pre-empt criticism ahead of the Chilcot inquiry, which is expected to be critical of Mr. Blair."

October 29, 2015, B.C.C., John Chilcot of the Iraq Inquiry said today, The "report on the Iraq war would not be released until the summer of 2016." (Actually not until John A. Askew's demise is accomplished).
