My name is Stanley Dimitroff. I have an address of 10484 Long Creek Hwy, Westminster SC, 29693. I've owned this Property about 25 years and paid Taxes to my county. As of 3-22-2015 I will be 55 years old. I am also disabled and live on a limited income.

The reason for this letter is to inform you and your office of the treatment I endured and continue to endure from the Oconee Co Sheriff's Dept. I've been in Pensacola FLA for almost 2 1/2 yrs taking care of my 80 yr old mother. In August of 2014 a Warrant went out on me from Oconee Co Sheriff for intent to Defraud not more than 10,000.

This case was an argument between me and a church (Life Changing Ministries) James Rodgers as Pastor almost 5 years ago. My wife of 20 yrs and I loaned the church \$5500.00 for metal through Blue Ridge bank. They were not and have not ever Paid this loan back.
