My NAME IS Landon Shelton 12/31/27

I LIVE IN MY OWN HOME ON THE WOODLANDS GOLF COURSE IN NORTH EAST COLUMBIA. I AM 88 YEARS OF AGE AND IN VERY BAD HEALTH - CONGESTIVE HEART FAILURE AND SERIOUS KIDNEY + OTHER PROBLEMS. I HAVE LIVED HERE SINCE 1993.

I AM A GRADUATE OF FURMAN UNIVERSITY WITH AN B.A. AND M.B. DEGREES. I COACHED FOR THREE YEARS AND A JUNIOR HIGH PRINCIPAL FOR 2 YEARS BEFORE MOVING TO MARYLAND WHERE I WAS A SCHOOL ADMINISTRATOR FOR 24 YEARS - SO I SPENT MY LIFE WORKING WITH CHILDREN AND TEENS.

WE MOVED BACK TO COLUMBIA IN 1993. IN 1998 WE WENT TO ~~Russia~~ RUSSIA AND ADOPTED 2 CHILDREN - I WAS 70 YEARS OLD ~~AT~~ AT THE TIME. ONE OF THE CHILDREN HAS DONE WELL - SABINA IS IN THE NAVY, SCOTT, THE OTHER CHILD, HAS HAD PROBLEMS FROM THE START - VERY HYPER AND A SLOW LEARNER. SCOTT ~~HE~~ WAS SEEN AND CARED FOR THROUGH SEVERAL PLACEMENTS BY CONTINUUM OF CARE OUT OF THE GOVERNOR'S OFFICE FOR SEVERAL YEARS. HE HAS SEEN MANY PSYCHIATRISTS FROM AGE 8 THROUGH AGE 16. (TO NO AVAIL.)

Despite ALL THAT WE COULD DO, HE DROPPED OUT OF SCHOOL AT AGE 16. SINCE THEN HE HAS BEEN ARRESTED FOR FORGERING CHECKS, USING OUR CREDIT CARD NUMBER FOR \$1500, AT WALMART, MARAWAHA (SOON), SPEEDING, BLUE LIGHTS VIOLATION, DRIVING WITH OUT A DRIVERS LICENSE, AND ABUSIVE, HURTING AND THREATENING ME!

Despite ALL THIS WE HAVE DONE OUR BEST TO GIVE HIM AN OPPORTUNITY TO HAVE A LIFE. HE HAS NOT HELD A JOB FOR MORE THAN 2 WEEKS THAT WE KNOW OF. On JAN 31, 2015 he AND HIS GIRL FRIEND (ALLIE KIEBEL) WANTED TO LIVE TOGETHER SO WE TOLD THEM THAT WE WOULD SIGN A LEASE FOR AN APARTMENT BUT IN ~~ONE~~ ORDER FOR THEM TO TAKE IT, THEY WOULD HAVE TO WORK, PAY THE RENT AND TAKE CARE OF THEMSELVES. WE WERE STUCK WITH THE LEASE BECAUSE ALLIE NEVER WORKED A DAY AND SCOTT

2 ONLY WORKED PART TIME - NEVER PAID \$1,00
TOWARD THE RENT, IN THE MEAN TIME, ALLIE GOT
PREGNANT AND HAD A BABY ON ~~DEC~~ DEC 31, 2015.
THEIR LEASE IS UP THIS SUNDAY JAN 31, 2016. I HAVE
BEEN TELLING THEM EACH MONTH, THAT AS OF JAN 31
THAT I WAS NOT PAYING ANY MORE FOR ANYTHING
AND NOT SIGNING ANOTHER LEASE. THREE WEEKS AGO
WE GAVE HIM \$3,000 TO GET A PLACE TO STAY AND
TO GIVE THEM 4-5 WEEKS TO GET JOBS AND BEABLE
TO CARE FOR THEMSELVES.

ON SUNDAY, (JAN 24th) THEY CAME TO OUR
HOUSE AND ASKED US TO SIGN A LEASE AND GIVE
THEM MONEY. WHEN I REMINDED HIM OF THE MONEY
WE HAD JUST GIVEN HIM HE BECAME ENRAGED AND
STARTED SCREAMING CURSE WORDS AT ME. I TRIED
TO SPEAK TO HIM BUT HE COULDN'T HEAR A WORD
FOR SCREAMING. I WAS IN MY RECLINER AND HE
CAME OVER, WHILE SCREAMING WITH HIS FACE
6 INCHES SO AWAY FROM MY FACE AND ~~SID~~ YELLED
"YOU THINK I WON'T HIT YOU? I WILL HIT YOU AND
I WILL KILL YOU!" IT WAS THE FIRST TIME
THAT I ACTUALLY THOUGHT THAT HE WOULD ATTACK ME.
I USE A WALKER AND A WHEEL CHAIR AND HAVE
NO WAY TO DEFEND MYSELF. I GOT UP AND WENT
INTO OUR BEDROOM TO LIE DOWN. MY HEART WAS RACING UP
AND I STARTED TAKING NITRO GLYCERIN

3. When I CALMED down ENOUGH, I CALLED THE police-
OFFICE START LUBINSKY OF REGION 7
5623 TWO NOTCH RD CAME AND ASSIGNED CASE #

My complaint is as follows

I WAS LYING ON MY BED (IN MY BEDROOM) AND ^{SCOTT} ~~HE~~ CAME TO THE DOOR AND SAID THAT HE WANTED ME TO COME OUTSIDE, I TOLD HIM TO COME IN - THAT I WAS NOT ABLE TO GET UP AND GO OUTSIDE.

THAT WAS OUR ONLY EXCHANGE before he left.

He DID NOT ASK ME ANY QUESTIONS OR ALLOW ME TO TELL HIM WHAT LED UP TO THE THREAT OR ANY OF SCOTT'S PREVIOUS JAIL HISTORY - HE HAS BEEN IN JAIL 4-5 TIMES AND SPENT THE MONTH OF JAN 2015 IN JAIL.

My wife told me that the deputy spoke to Scott in the front of the house so apparently he got not come back in and tell me what was said. so he had no idea of the truth

I CAN'T BELIEVE THAT UNWANTED TOUCHING CAN RESULT IN AN ARREST AND A WITNESSED TO KILL (IN A SCREAMING FIT OF RAGE) WOULD BE LEGIT HOW ABOUT ASSAULT, HARASSMENT OVER YEARS ETC

I AM WRITING THIS BECAUSE I DON'T ^{WANT} SOMEONE ELSE TO BE TREATED THIS WAY. HE COULD HAVE (AT LEAST) COME IN AND TALKED TO ME. ALSO, I FOUND OUT THIS CASE WAS NOT REPORTED.

I AM A believer in the Lord and know
Vengeance is ~~is Not~~ way but I do
believe that this man does not represent
A police department that CARES about the
Citizens who try to live by the rules.


