Thank you for running down the hall to assist Senator Thurmond's constituent. I received your message (I was on the phone with this other constituent). Oddly enough, I just hung up with one of Senator Malloy's constituents out in Darlington. This gentleman is having difficulty with his unemployment. The details are a bit confusing. It has to do with overpayments, which SCDEW mistakenly issued and said that they would fix the internal mishap to get his unemployment checks to him. I don't know how all this works, so I'm just going to ask that you help us look into the current status of his situation. Here are his details:

His phone was just cut off, so he is using his neighbor's phone – 843-378-0092. His electricity is getting ready to be cut off also. The last unemployment checks he received were before Thanksgiving. He said he has been doing his weekly filings and complete his eligibility review in December. The problem seems to stem from internal "wrong processing" for a lack of a better word. He said 5 letters came saying he was over paid by \$11,000. When he has called your agency, he said that he always talks to someone different. Their response is always – this is not your fault, we'll correct it, but then a check never comes.
