House Speaker Bobby Harrell was indicted by a grand jury Wednesday on nine ethics and misconduct charges, sparking calls from the governor and others for him to step aside from his leadership post until his legal troubles play out.

**Note:** Gov. Nikki Haley joined the list of those calling on Harrell to step down. When asked if Haley thought Harrell should resign his post, spokesman Doug Mayer answered "yes" but would not comment further

South Carolina House Speaker Bobby Harrell was indicted Wednesday on misdemeanor charges that he misused his office for personal gain and lied to law enforcement about his campaign expenses, according to court documents.

**Note:** Others calling for Harrell to resign his powerful speaker's post while the case plays out include Republican Gov. Nikki Haley; her Democratic challenger, state Sen. Vincent Sheheen; and state Democratic Party Chairman Jaime Harrison.

After months of trying to shut down an investigation into his use of campaign money, S.C. House Speaker Bobby Harrell was indicted Wednesday on nine charges, including illegally using campaign money for his personal expenses, filing false campaign disclosure reports and misconduct in office.

**Note:** Shortly thereafter, Republican Gov. Nikki Haley and several House members said Harrell should resign as speaker.

**Note:** Haley would not elaborate on why she thought her fellow Republican should step aside. But the pair have quarreled for years, dating back to her days as a state representative from Lexington when, she said, Harrell stripped her of a choice committee assignment.
