On December 3, 2014 at 1620 a UH-60 assigned 59th AVN TRP CMD made a precautionary landing in a field near I-77 close to the City of Columbia water treatment facility. No SMs were injured in the landing. Please see attached picture for general aircraft location along with the effects on traffic. There has been local news coverage in the Columbia area.
