Dear Mr. Kennedy:

Pursuant to § 22-2-5, all prospective magistrates seeking an initial appointment must pass an eligibility examination testing basic skills. The test has two components- the Watson-Glasser Critical Thinking Appraisal and the Wonderlic Personnel Test. By Order of the Supreme Court dated October 9, 2002, an applicant must score an aggregate of 68 of the two tests for passage. The technical college where the tests were administered has informed us that you took the examination on February 4, 2015, and received an aggregate score of 77 on the two tests. Therefore, you may be considered by your senatorial delegation as a prospective magistrate. Those members will be notified of your score pursuant to your signed release of information. You may wish to retain this letter for your records.
