since Nov 09 2104, this incident transpired on Nov 10 2014 i requested a bp 8 i have been denied to file my counselor been spinning me refusing to provide me remedy. I was verbally assaulted by a sexually harrassive comment that was made by officer mr k brantner on nov09 2014 : who told me to suck his penis, the nature if this comment was both deprivating and debasing. one of the lowest things you can say to another man. I found this shocking and highly offensive comment to be retaliatory in nature and I did not condescend to give his un dignified comment any response finally no man especially a man wheel chair bound should be subjected to such sexually hostile verbal abuse from any staff member at any time which is totally inconsistent with the f.b.o.p polices. and my unit team is supporting this officer mis conduct denying me to file grievance ...
