ADVANCE SHEET UPDATE

April 27, 2016

In this criminal appeal of convictions for murder, trafficking cocaine, possession with intent to distribute cocaine base and possession of a weapon during the commission of a violent crime the S.C. Court of Appeals affirmed the trial court's decision. The court held, inter alia, that the magistrate had a substantial basis for determining the totality of the circumstances there was probable cause to search Wright's home. The court further held that the use of supplemental oral testimony to supplement inaccurate information in the affidavit was not inappropriate in this case because there wasn't any evidence that the detective intentionally, knowingly or recklessly supplied the inaccurate information. In regard to the search warrant's validity, the court held that the issuance of the search warrant did not violate the South Carolina and federal constitutions or section 17-13-140.
