M I N U T E S

PRESENT: Chairman - C. Edward Poore

Mr. Poore called the meeting to order and Mr. Wright gave the invocation.

On the motion of Mr. Wiles, seconded by Mr. Wright, Council voted unanimously to approve the minutes of the June 18 and 19, 1979, meetings as mailed.

Interested citizens of the Lebanon Community spoke concerning their opposition to the Allgood 4-wheel vehicle rally scheduled to be held on July 1, 1979. In answer to the opposition, the County Attorney stated that he would check into the matter and see if another meeting would be necessary. On the motion of Mr. Wright, seconded by Mr. Wiles, Council voted three to one to reconsider the vote of April 3, 1979, allowing the Allgood race to be conducted. Mr. Wiles, Mr. Rhodes and Mr. Wright voted in favor of the motion and Mr. Gerrard abstained.

On the motion of Mr. Wright, seconded by Mr. Rhodes, Council voted three to one to deny the permit that had been issued. Mr. Wiles, Mr. Rhodes, and Mr. Wright voted in favor of the motion and Mr. Gerrard abstained.

Mr. Kirt Pruitt and Mr. Curtis King discussed water problems on Horseshoe Bend. Mr. Poore asked the County Attorney to check into the matter.

On the motion of Mr. Rhodes, seconded by Mr. Wright, Council voted unanimously to have the meeting that is tentatively scheduled for Thursday, June 28, 1979, to be at 7 p.m.

Mrs. Linda Gilstrap discussed sealed bids for Pramital 25E. On the motion of Mr. Wiles, seconded by Mr. Wright, Council voted unanimously to award the bid to Kaiser Agricultural Chemical, which was the lowest bidder.

On the motion of Mr. Rhodes, seconded by Mr. Wright, Council voted unanimously to adopt Ordinance No. 36 (Anderson County Alcohol and Drug Abuse Commission) on third and final reading.

On the motion of Mr. Rhodes, seconded by Mr. Wiles, Council voted unanimously to adopt Ordinance No. 37 (Anderson County Library Commission) on third and final reading.

Council adjourned at 6:45 p.m.
