
Representative J. Roland Smith contacted this agency on your behalf regarding Medicaid eligibility and your healthcare needs.

Your application for Medicaid's Aged, Blind or Disabled program was denied in June 2012 because the Social Security Administration (SSA) denied your disability claim. Medicaid uses the same disability guidelines as the SSA when determining eligibility and we are required to adopt their disability decision. If you are appealing the SSA decision and the decision is reversed, please notify your local eligibility office because you may also be eligible for Medicaid at that time.

Enclosed is information on other programs and organizations that can assist residents in South Carolina with their healthcare needs, prescriptions and inpatient hospitalization.
