I am concerned about the requirement to break out meals by frozen or hot in our budgets.

Budgets are about the amounts and funding source and the unit costs do not change based on whether it is hot or frozen. That really has absolutely nothing to do with the budget. It appears that the way they are having us set our budgets up will result in the need to update them monthly, which is crazy. While much of what the LGOA has asked us to do seems to make no sense and is frustrating, time-consuming and costly, this requirement just won't work. Would you possibly talk to someone at the LGOA about this?
