My name is Allison Renee' Moak and I have a 21 month old son with James Michael Watts (SCDC #362070). Michael attended a parole hearing on 5/25/2016 and was rejected. Michael was sent to SCDC 11/4/2014 due to a probation violation. After completing Kirkland Reception & Evaluation, Michael was given a custody level of 1B-minimum out-Restricted and was sent to Walden on Broad River Road. Michael's original sentence for the Felony Dui with Great Bodily Injury in which he was on probation for was 8 years, however, when his probation was revoked, he was given time served for the amount of days he served in the county before he originally went to trial in 2011. Back in 2011, Michael went thru a hard divorce and moved back in with his dad and stepmom. This was a negative environment in which Michael's dad used prescription drugs. At that time, Michael's addiction continued to spiral out of control and as a result he was involved in the accident and got the Felony Dui. He sat in the county jail for approximately 11 months before trial and then accepted a plea deal of which was 8 years suspended to 5 years of probation and to complete the Bethel House Ministries. Due to the negative environment in which Michael was living in with his dad and stepmom and the choices Michael made for himself, he failed at probation and completing the Bethel House and his probation officer, 2 year later, violated him. On 11/4/2014, when our son was 8 weeks old, we went to the probation hearing and the judge revoked his probation.

Since that time, Michael has been incarcerated and I have stood by him. I have attended every weekend visit and have taken our son to visit him as well.

On 5/25/2016, we attended McCormick Correctional for the parole hearing and was rejected. During that hearing, I feel that there were several topics that were vital to the case that were misunderstood and/or false. Those reasons are listed and explained below.

1. When it was explained that Michael moved back in with his "Folks" after his divorce it was not explained that it was his dad and his stepmom. His mom was at the hearing in support of him and she is an extremely positive role model for Michael and lives a clean, healthy lifestyle. I felt like this not being clarified and then her being there offering her support caused quite a bit of confusion.
2. Another huge vital piece of information that was misunderstood from the very beginning of the hearing was the probation violation. The parole board was under the assumption that Michael was on probation when he was charged with the Felony DUI. He was not. He violated probation AFTER the Felony DUI. However, his probation, whom is no longer with the department waited 2 years to violate him.

3. The parole board also questioned him regarding a “pending infraction” on his SCDC disciplinary record during the hearing. He does not have any pending infractions nor does he have any disciplinary charges. He was moved to Trenton Correctional on 3/27/2016 for a disciplinary but it was overturned because another inmate was running from a correctional officer and Michael was on the phone with me at the time and he handed something to Michael to try to not get in trouble with the correctional officer in which he was running from. At the time, they shipped both of them to Trenton. Later, Michael was charged with the disciplinary but later it was overturned when it was proven that Michael was completely INNOCENT.

All three of these points changed the tone and direction of the hearing of 5/25/2016. The board did not even ask Michael if he had anything he would like to say. Our attorney (Tommy Thomas) had to ask Michael if he had anything to say. Without these miscommunications and/or false information, I feel the hearing would have went in a different direction and would have held a different tone.

Michael has done everything he can to better himself and prepare himself for parole. Those reasons are listed and explained below.

1. Completed ATU successfully on his own – was not court ordered or paroled to the program like most inmates are nor was he sent there or encouraged to complete the program by his attorney.
2. Obtained and kept a minimum security level.
3. Was awarded IRC at ATU at Lee County which is a very high privilege.
4. Learned the trade of Welding and earned the title of Senior Welder at Trenton, which is the highest title in Welding. (He can use this trade to support his family and gain a career).
5. Offered to pay back 100% of the restitution to Mr. Keener without being court ordered to do so.
6. Extremely large support system. Has worked on bettering his relationship with the people who are positive in his life (has cut out the negative people like his dad and stepmom).
7. Has treatment lined up at the Alpha Center for after release – outpatient treatment plan in place.
8. Has a stable, permanent residence with myself, our son and my daughter (will no longer be residing with his dad and stepmom).
9. Has an employment offer and letter included in his parole packet. Would also like to work on finding a job in welding once released and continue his certification and trade in welding.
10. Has a High School Diploma.
11. Participated in NA meetings and Men’s Ministry the entire time at Walden at SCDC.

Michael had already violated probation once Langston was born. Langston was only 8 weeks of age when we attended the probation revocation hearing. Michael seeing how much he has missed out the past 19-20 months of Langston’s life and how only seeing him a few hours on the weekend affects not only Langston but himself and myself has


changed Michael. Michael has admitted and accepted his addiction problem for the first time in his entire life and that is why he went to ATU on his own to get help. He finally wanted to get help for himself. I was so thankful he finally admitted his addiction and finally wanted help for himself.

Michael's mom was recently diagnosed with stage 4 Colon Cancer. This has also made Michael realize how he can no longer take things for granted and has really changed him for the better. I have seen a huge difference in Michael since this. I no longer see the selfishness. I see a Michael that cares and wants to help and who is genuine.

One thing that has stood out to me the absolute most during the past 20 months of this incarceration, is the fact that Michael has realized and saw how much pain his actions has caused on Mr. Keener and his family and how much remorse Michael has for what has happened. I have seen so many changes in Michael and I see a different side in Michael each and every day.

I would like to ask for the South Carolina Department of Probation and Parole to think about all of the points I have made and reconsider listening to the parole case for James Michael Watts (SCDC 362070).

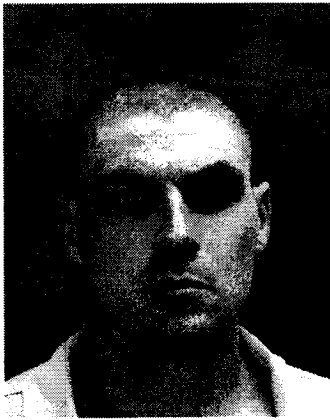

I am James M. Watts, my inmate number is 362070, I am currently incarcerated at L.C.I enrolled in the ATU Program.

The ATU Program helps addicts and also teaches how to not become a repeater in the Prison system.

First I want to Thank you all for taking the time to look over my Poble Packet, and giving me the opportunity to speak on my behalf, to why I should be released back into Society on a early release.

I take full responsibility for my actions and am no longer in denial about my drug use and actions. I have a Problem with drug use and here at ATU I am getting the tools I need to not use. Being incarcerated in SCDC has been a rough time away from family & my son. It took coming here to see that I had hit rock bottom and needed help with my addiction.

Leaving my son behind with his mom at the age of 8 weeks was one of the hardest things while being gone. I took for granted the time I had. Now that I have got clean & sober I can see things alot more clearer. I need to be home to help with my son, his mother has to support him by herself and it isn't fair. I have changed my ways and know that I need to be home raising my son and showing him right from wrong by what I have been through.

I have a huge family support system with a lot of positive and drug free environments that I will surround myself around when released.

Here at ATV I have ~~been~~ been in many classes that I much needed. In our daily schedule we go to NHTAA classes, positive thinking classes and Criminal thinking. With the tools and advice from the counselors that are here on staff, they have prepared me to go back into society. I came to ATV on my own not court ordered or Paroled here I came here on my own to get help. I knew that I had a problem and it needed to be taken care of. I wrote the director of ATV and asked if I could join the Program I was accepted and came in September.

Also here at ATV I have the Highest Job structure which is IRC [Inmate Representative Committee] I work with the Warden and Inmates to come to answers to suggestions & concerns for my dorm.

Again thank you for reading my letter. I am not the man I was when I was sentenced to SCDC I am changed, it took me coming to SCDC and entering a drug treatment Program to realize that I had a problem and was in denial I'm no longer that man.





Programs & Services

- **Primary Prevention**

The prevention program is designed to reduce or eliminate factors that increase the probability of an individual's involvement with alcohol and other drugs. This goal is accomplished through comprehensive planned activities delivered to schools, churches and community groups. The Community Action for a Safer Tomorrow (CAST) coalition is also a current prevention program.

- **CBT: Community Based Treatment**

This program provides counseling services to individuals and families in the least restrictive setting. CBT provides an array of services to address the specific problems in a variety of modalities that includes: group, individual and family counseling.

- **YAS: Youth & Adolescent Counseling**

YAS is a joint effort of The ALPHA Behavioral Health Center and community agencies working together with schools and parents to help troubled youth. The YAS service offers alternatives to those students who are experiencing various problems: academic, social, emotional or behavioral in nature. The goal of YAS is to help students stay in school.

- **ADSAP: Alcohol & Drug Safety Action Program**

ADSAP is designed to increase safety on our roads by helping persons make positive changes to reduce their risk of getting another DUI/DWI offense. This program is offered under the direction of the South Carolina Department of Public Safety and meets all the South Carolina state requirements.

- **CDV: Criminal Domestic Violence Program**

A certified approved program through the South Carolina Department of Social Services, this program runs for 26 weeks and provides intervention to perpetrators of domestic violence.

- **EAP: Employee Assistance Program**

The EAP provides education and counseling services for employees whose job performance is adversely affected by alcohol and other drug abuse and/or personal problems. Family members can also receive help through the EAP or can participate in the employees' counseling program.

- **OBI: Offender-Based Intervention**

Assists persons involved with the Adult Criminal and Juvenile Justice systems to reduce alcohol and other drug use and/or risk behaviors and to promote positive behavioral change.

- **PTI: Pre-Trial Intervention**

Participants are referred from the Solicitor's Office and upon successful completion, their criminal record will be expunged and they will not stand trial. The goal of PTI is to develop lifestyle risk reduction.

- **Drug Court**

A criminal justice diversion program that offers an alternative for those person whose crimes are the result of their drug addiction. This program helps keep nonviolent offenders out of prison and puts them back on a productive path. Participants in this program are normally involved in treatment for at least one year.

- **Parenting Classes**

Aimed to teach parents how to deal with each other while protecting their children and also to make parents realize how their actions can affect their children. In some cases, feuding parents are required to attend parenting classes to attempt to resolve (or prevent) problems.

- **Alcohol & Other Drug Testing**

A full range of alcohol and drug testing as well as training services are provided to employers and agencies to support a drug-free workplace. We offer US DOT and non-DOT testing variables to meet the consumer's ever changing needs.

Urine Screening

Urine drug screening is still the most widely used and most economical form of testing. Urine screens will test from 1-10 drugs and detection window varies based on the drug. Drugs may be detected in the system from only hours of use up to 3-4 weeks (depending on the drug). Urine drug testing is the most widely used method and currently yields the quickest results. Our tests are available in both instant, and lab-based formats.

Hair Analysis

Hair analysis has gained popularity as the screening method that covers the most "history" of drug usage. While hair testing yields usage up to 90 days, it is not recommended for monitoring drug use within the last 14 days since use (due to the inability to cut "new" hair that may hold the drug metabolite). Hair analysis is far more effective than urine testing in identifying low-level drug use over an extended period of time.

The ALPHA Behavioral Health Center provides prevention, intervention and treatment services. However, not all counties provide the same services. Please contact the office nearest to you for more details and to schedule an appointment.

Step-by-Step Success

Step 1: To make an appointment for services, please contact the appropriate county office to schedule an appointment time.

Step 2: All clients receive an intake/orientation and assessment to determine specific needs for services and if we can best meet those needs.

Step 3: Information from all dimensions is collected during the assessment to assist in problem identification and to determine severity. From this, a primary counselor is assigned to your individualized treatment needs.

Step 4: After Treatment Team recommendations, the individual is placed in the appropriate level of care. Referrals are made when necessary.

Step 5: The individualized treatment plan defines the level of care for services and states goals and desired outcomes of services provided, and is updated as needed.

Step 6: The progress of the individual is closely monitored by the client, the counselor and the treatment team. Upon completion of the individualized plan, the client is provided a continuing care plan and follow-up services as needed.

About Us



The Kershaw County Commission on Alcohol and Drug Abuse operates under the name of The ALPHA Behavioral Health Center in Kershaw and Chesterfield counties and The Lee Center in Lee County. It offers programs that provide a full range of alcohol and other drug services to local citizens. A private non-profit organization, The ALPHA Behavioral Health Center is supported by contracts with individual organizations through EAP and

other services, local, state, and federal contracts, as well as fees incurred by clients for services delivered. The ALPHA Behavioral Health Center operates solely under the direction of a self-

perpetuating Board of Directors.

Since its inception over 35 years ago, The Kershaw County Commission on Alcohol and Drug Abuse has come to meet a broad range of community needs. The commission was established by state law on March 5, 1973, as a county organization dedicated exclusively to the prevention and control of all forms of substance abuse. The agency began operating as The ALPHA Center in 1989. By 1993, its expanding area of service encompassed Chesterfield County, and in July 1996, included Lee County. Today it is known as The ALPHA Behavioral Health Center, and offers many innovative and effective treatments, intervention and prevention programs designed to reduce the impact of alcohol, tobacco and other drugs for citizens of Kershaw, Chesterfield and Lee Counties.

Notice of Privacy

THIS NOTICE DESCRIBES HOW MEDICAL-AND ALCOHOL AND OTHER DRUG-RELATED INFORMATION ABOUT YOU MAY BE USED AND DISCLOSED, AND HOW YOU CAN GAIN ACCESS TO THIS INFORMATION. PLEASE REVIEW THIS NOTICE CAREFULLY.

General information regarding your health care, including payment for health care, is protected by two federal laws: the Health Insurance Portability and Accountability Act of 1996 (HIPAA), 42 U.S.C. 1320d et seq., 45 C.F.R., Parts 160 & 164, and the Confidentiality Law, 42 U.S.C. 290dd-2, 42 C.F.R., Part 2.

Under these laws, The ALPHA Behavioral Health Center may not say to a person outside the agency that you receive services through this agency, nor may this agency disclose any information identifying you as an alcohol or other drug abuser, or disclose any other protected information except as permitted by federal law.

This agency must obtain your written consent before it can disclose information about you for payment purposes. For example, this agency must obtain your written consent before it can disclose information to your health insurer in order to be paid for services. Generally, you must also sign a written consent before this agency can share information for treatment purposes or for healthcare operations. However, federal law permits this program to disclose information *without* your written permission:

1. pursuant to an agreement with a business associate;
2. for research, audit or evaluations;
3. to report a crime committed on this agency's premises or against personnel of the agency;
4. to medical personnel in a medical emergency;
5. to appropriate authorities to report suspected child abuse or neglect;
6. to appropriate authorities to anonymously or by court order report suspected abuse or neglect of an elderly person or a vulnerable adult; and/or
7. as allowed by a court order.

For example, this agency can disclose information without your consent to obtain legal or financial services, or to another medical facility to provide health care to you, as long as there is a business associate agreement in place.

Before this agency can use or disclose any information about your health in a manner that is not

described above, it must first obtain your specific written consent allowing it to make the disclosure. Any such written consent may be revoked by you in writing.

Your Rights

Under HIPAA, you have the right to request restrictions on certain uses and disclosures of your health information. This agency is not required to agree to any restrictions you request, but if it does agree, it is bound by that agreement and may not use or disclose any information that you have restricted, except as necessary in a medical emergency. You have the right to request that representatives of this agency communicate with you by alternative means or at an alternative location. This agency will accommodate such requests that are reasonable and will not request an explanation from you. Under HIPAA, you also have the right to inspect and copy your own health information maintained by this agency, except to the extent that the information contains psychotherapy notes or information compiled for use in a civil, criminal or administrative proceeding or in other limited circumstances. Under HIPAA, you also have the right, with some exceptions, to amend healthcare information maintained in this agency's records, and to request and receive an accounting of disclosures of your health-related information made by this agency during the six years prior to your request. You also have the right to receive a paper copy of this notice.

Agency Duties

This agency is required by law to maintain the privacy of your health information and to provide you with notice of its legal duties and privacy practices with respect to your health information. This agency is required by law to abide by the terms of this notice. This agency reserves the right to change the terms of this notice and to make new notice provisions effective for all protected health information that it maintains. You will receive a copy of this notice at intake. When changes are made to this document, current clients will be contacted with the revisions.

Complaints and Reporting Violations

If you believe that your privacy rights under HIPAA have been violated, you may complain to this agency and the Secretary of the United States Department of Health and Human Services. In this event, your complaint must be in writing and submitted to the HIPAA Compliance Officer for this agency. You may also make a complaint to the South Carolina Department of Health and Environmental Control, Division of Health Licensing, at (803) 545-4370. You will not be retaliated against for filing such a complaint.

Violation of the Confidentiality Law by a program is a crime. Suspected violations of the Confidentiality Law may be reported to the United States Attorney in the district in which the violation occurs.

Ethical Considerations

The ALPHA Behavioral Health Center fully supports consumer rights. The agency staff makes every effort to assure every person is treated fairly without consideration of disability sex, religion, race or culture heritage. The ALPHA Behavioral Health Center fully complies with the standard of ethics as set forth by the National Association of Alcohol and Other Drug Abuse Counselors as well as the agency's Code of Ethics. These standards are posted in prominent places in each site. If you have any questions about them, you may ask any of our staff members to assist you.

Grievance Procedures

Any person served who think he or she has been mistreated may use the following procedure for grievances:

- Take the grievance to your case manager immediately
- Your case manager, the supervisor, and you will meet within 14 days of the grievance
- If the grievance cannot be resolved with the case manager, the supervisor and you, then the next step is to schedule a Treatment Team meeting to review the grievance. The Team will consist of you the client, the primary case manager, the supervisor, and your referral source. This meeting will occur within 10 days of the previous meeting
- If at this point the grievance cannot be resolved, the above listed persons will meet with the Executive Director of The ALPHA Behavioral Health Center within five days of the treatment team meeting
- Results of the findings will be addressed according to Policy and Procedure

Confidentiality

All services are considered confidential and are protected by Federal Law (42 CFR Part 2) and the Health Insurance Portability and Accountability Act of 1996 (HIPAA). Due to confidentiality regulations, all individuals must sign a release of information regarding their protected health status. This information must be clearly explained to you upon admission for services.

If you do not believe it has been explained to you, please ask your case manager for more information.
