To Whom It May Concern:

I was a guest at the above cited hotel on 7/24/2016 - 7/26/2016 in room 148 upon which Lisa checked my partner in under "Michael Lael," whom the reservation was under. During my time at the hotel, my back right tire was slash -- the hotel was made aware -- my car stolen, and returned shortly thereafter, and over \$500.00+ was taken during the process along with cosmetic products, a Google TV device, and my Internet connection was monitored, tampered with then "phished" to steal one of my marketplace accounts that contained over \$750.00 in currency (1.73 - 2.90 BTC).

The marketplace, AlphaBay, confirmed that I was a victim of a phishing attack and illegal cyber intrusion that resulted in all money being lost. All of the BTC/money was stolen and is now in the possession of criminals who likely entered, resided in or simply used the WiFi at this location.

Any information, tips, guidance or knowledge that you may be able to provide me, local authorities, or the FBI would be greatly appreciated.

Thank you for your time and hospitality. It's appreciated and a small step to ensuring the safety, privacy, wellbeing of your guests and the civil and human rights of all...

Lieutenant Westmoreland, Inspector Ryan Smith and Deputy John Belding and finally the CRIME STOPPERS hotline (twice). None of which have yet to respond, and as a result more criminal activities have and will take place at the above cited hotel and likely against me and others within the state of South Carolina. HELP? Please.
