The Republicans of Sun City Hilton Head would be greatly honored if Governor Nikki Haley could speak to the Sun City Community either before or after her speech at the joint event, sponsored by the 1st Monday Republican Club and the Hilton Head Island Republican Club, on October 6, 2014.

A Sun City event would be open to the entire Sun City community and would be widely publicized. Our format would be a 15-20 minute speech with question and answers, although we can tailor this to the Governor's requirements.

Could you please let me know if it would be possible for Governor Haley to speak to Sun City on October 6? If this date does not work, we would be happy to schedule an event at another time that would work with the Governor's schedule.

Once we have settled on a date, I will submit a room request and send you the Political Package that sets out rules governing the event. A signed copy of the Political Package is required to be submitted to our Community Activities.

I know you are familiar with Sun City Hilton Head. Our active adult community now has a population that is over 14,000 and growing. Sun City's precincts have some of the highest voter turnouts in South Carolina. Politically, the majority of residents in our community are Republicans, but more Democrats and Independents have been locating here in recent years. The Sun City Democrats are getting more active and will be pushing their candidates heavily during the fall.

However, the Republicans of SCHH have been hosting successful political events for many years and we are working hard to ensure that Sun City residents get a chance to hear from our Republican candidates this fall.

Thanks for considering our request for Governor Haley to visit Sun City Hilton Head.
