Thank you for helping us obtain information regarding the services for aging and vulnerable adults provided by and through the Office of the Lieutenant Governor. As we discussed, I would like to obtain the following information by email:

1. A detailed, **current** organizational chart for the Office of the Lieutenant Governor, with the names of staff members included on the chart.
2. A copy of the **current** Office of Lieutenant Governor contracts with councils of government for (a) ombudsman services and (b) aging network services.
3. A list of the ombudsman and aging network staff in each of the councils of government **currently and as of June 30, 2016**.
4. An **SFY 2015-2016** financial report specifying detailed revenue sources and expenditures for the Office of the Lieutenant Governor, including figures separately for the ombudsman program and the aging network program.
5. **SFY 2015-2016 and calendar year 2016** data on the maltreatment reports received by the ombudsman program. Separately for each ombudsman entity receiving maltreatment reports (e.g. Office of the Lieutenant Governor, council of government, etc.) please indicate:

(a) the number of reports received by type of report

(b) the number of investigations initiated by type of report

(c) the number of investigations completed by type of report, and

(d) the number of case decisions by type of report and category of decision.
