SECTION 1: The Minutes of the meeting of May 17, 1990; copies of which have been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion accepting monthly reports as published by the Department of activities for the month of May, 1990.

SECTION 3: The Commission unanimously passed a motion approving purchase orders issued for amounts in excess of \$1,000.00 during the month of May, 1990, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion authorizing the Department to enter into a supplemental agreement with the City of Rock Hill for expediting improvements to S. C. Route 161 and the extension of Dave Lyle Boulevard at an approximate cost of \$4,900,000.00, as shown in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the action of the Department in entering into supplemental agreement #2 with Deleuw Cather & Co./LPA Group, Inc. to provide mapping of approximately 12.4 miles on U. S. Route 521 at a cost of \$75,030.00, as shown in the Appendix.

Section 6: The Commission unanimously passed a motion authorizing the Department to enter into supplemental agreements with Howard Needles Tammen & Bergendoff to provide additional engineering services for a pile load test program on the Socastee Bridge Replacement project at a total cost of \$529,600.00, as shown in the Appendix.

SECTION 7: The Commission unanimously passed a motion authorizing the Department to advertise and select a consulting firm for the purpose of entering into an agreement to provide inspection services on an "as needed" basis for structural steel, signs and related materials at various fabrication plants at an average approximate cost of \$80,000.00 per year, as shown in the Appendix.

SECTION 8: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with MacDorman & Associates, Inc. to conduct management audits/performance evaluations of five transit systems at a contract maximum of \$92,500, as shown in the Appendix.

SECTION 9: The Commission unanimously passed a motion authorizing the Department to enter into an agreement with the ATE Management and Service Company, Inc. to conduct a public transportation ridership profile and marketing/promotional planning project at a contract maximum of \$99,959, as shown in the Appendix.

SECTION 10: The Commission unanimously passed a motion adopting the following estimates of revenue and requirements for fiscal year 1990/91. The budget presented in the Recommendations was adopted with the following changes: maintenance apportionment of "C" secondary funds deleted, revenue estimate of drivers license reinstatement fees recognized with highway maintenance and wildflowers apportionments adjusted. The budget as adopted is shown in the Appendix.

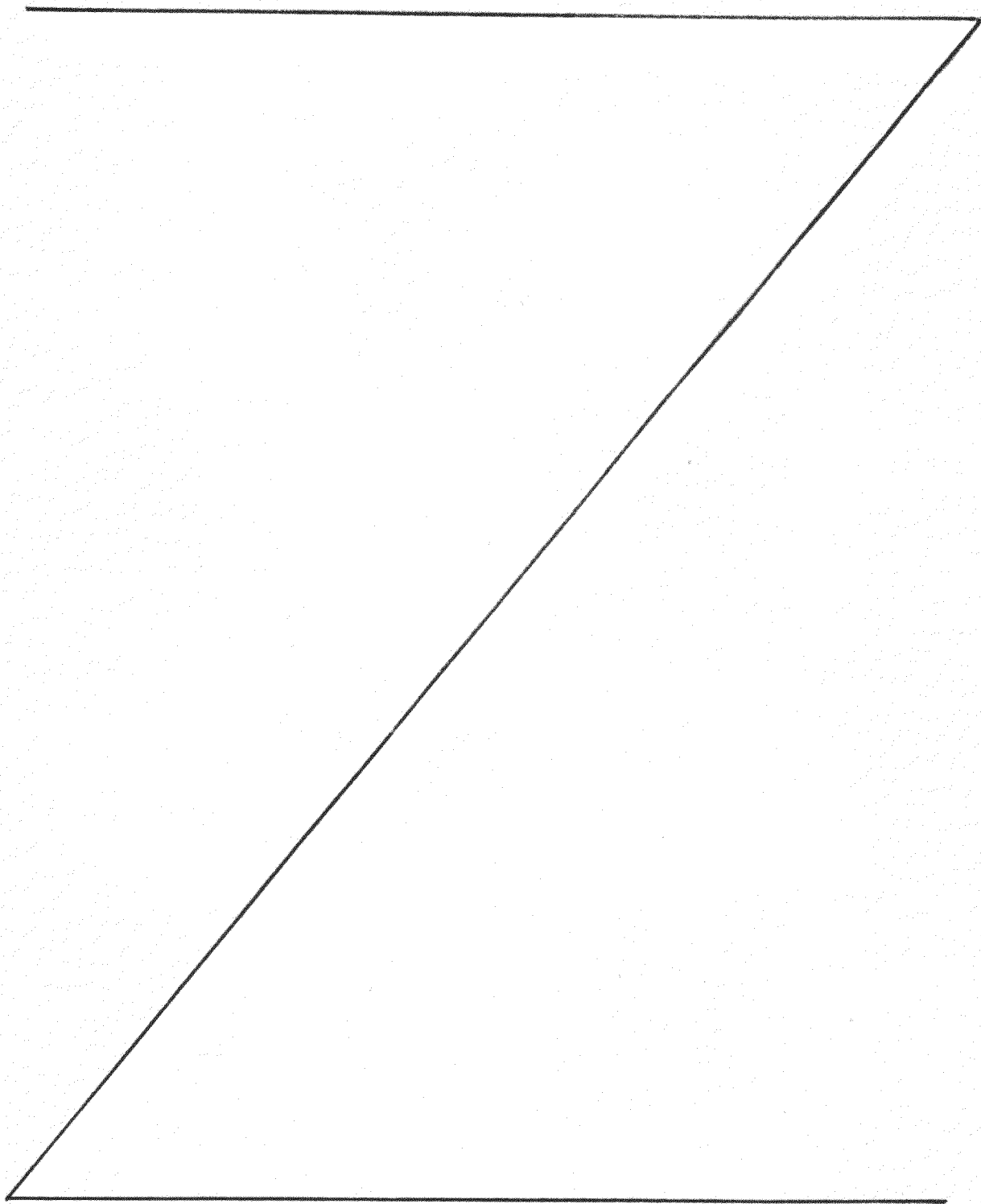

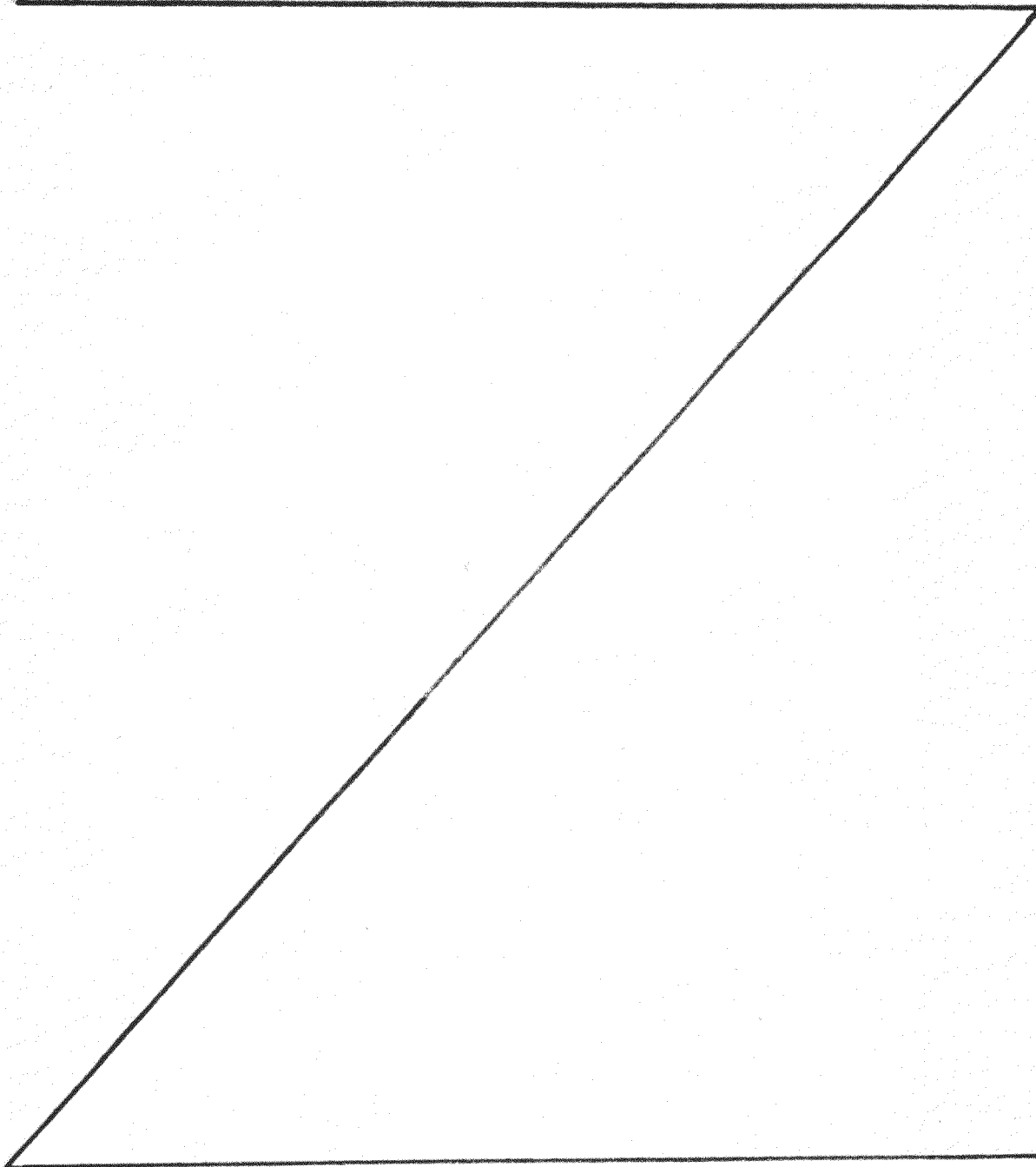

AGREEMENT FOR CONSULTANT SERVICES

The Department requests Commission approval to advertise for and select a consulting firm for the purpose of entering into an agreement to provide inspection services on an "as needed" basis for structural steel, signs and related materials at various fabrication plants.

The scope of work will involve fabrication inspection of structural steel and signs and nondestructive testing of welds.

Funding for this project will be from monies set up for the various construction projects on which the materials will be used. Cost will vary according to services needed but will average approximately \$80,000.00 per year.

AGREEMENT WITH MACDORMAN AND ASSOCIATES, INC.

At the June 16, 1988 and June 20, 1989 meetings of the Commission, the Department was given authorization to proceed in the conduct of management audits and performance evaluations of transit systems. The authorization allowed for the expenditure of Urban Mass Transportation Administration Section 8 funds (\$41,680), Section 18 Program Administration Funds (\$40,400), and State Highway Funds (\$10,420) -- total project cost not exceeding \$92,500.

With this approval, a bid solicitation, review and selection process was conducted through the State's Budget and Control Board, Materials Management Office (MMO). MMO has concluded that MacDorman & Associates, Inc., submitted the most responsive and responsible proposal, and issued an intent to award on June 5, 1990. The official statement of award shall become effective June 22, 1990, at 5:00 pm.

It is, therefore, requested that the Commission authorize the Department to enter into an agreement after June 22, 1990, with MacDorman & Associates, Inc., for a contract maximum of \$92,500 to conduct management audits/performance evaluations of five transit systems.

AGREEMENT WITH ATE MANAGEMENT AND SERVICE COMPANY

At the November 16, 1989 meeting of the Commission, the Department was given authorization to enter into an agreement with ATE Management and Service Company for consultant services to conduct a public transportation ridership profile and marketing/promotional planning project. After receiving the authorization, a protest was filed on the award to the State's Budget and Control Board's Materials Management Office (MMO) by an unsuccessful offeror. Subsequently, a grievance was filed by the aggrieved party with the State's Procurement Review Panel. The Panel ordered that appropriate revisions be made to the RFP and that the MMO re-bid the project.

A bid solicitation, review and selection process was conducted through MMO. MMO has concluded that the ATE Management and Service Company, Inc., submitted the most responsive and responsible proposal, and issued an intent to award on May 21, 1990. The official statement of award became effective June 7, 1990.

Funds for this project were authorized at the June 16, 1988 and June 20, 1989 meetings of the Commission. The authorization allowed for the expenditure of Urban Mass Transportation Administration Section 8 Funds (\$57,536), Section 18 Program Administration Funds (\$28,080), and State General Funds (\$14,384). The total project cost was not to exceed \$100,000.

It is, therefore, requested that the Commission authorize the Department to enter into an agreement with the ATE Management and Service Company, Inc., for a contract maximum of \$99,959 to conduct a public transportation ridership profile and marketing/promotional planning project.

It is recommended that the Commission approve the Statewide allocation of \$3,189,651 in federal and state funds to assist in the administration, planning, capital, operation and maintenance expenses of public transportation projects for fiscal year 1990-'91 as outlined on the attached schedule. In accordance with Code Sections 57-3-1010 and 57-3-1050, these projects have been reviewed and endorsed by the Interagency Council on Public Transportation's Joint Committee on Procedures, Review & Research.
