In this budget, the new Center for Educational Partnerships gets \$715,933.

That includes what had been in FY 2012-13...

- . Writing Improvement Network: \$182,761
- 2. SC Geographic Alliance: \$155,869
- 3. School Improvement Council: \$127,303

Total of those components is \$465,933

So the new CEP is getting exactly \$250,000 more than the sum of those parts. Note again that WIN and SCGA both received a 1.8 out of 5.0 from the EOC a year ago, which means they were tied for being the second-lowest rated of the programs evaluated by EOC.
