### Information Technology and the Aging Network: Opportunities to Enhance Information Technology Capacity

The Altarum Institute has released a new report on information technology and the aging network. The report examines opportunities for the Aging Network to expand partnerships with health care organizations and other entities through focusing on the value of investing in information technology (IT).

This report also focuses on a federal funding opportunity and the experiences of three AAAs that are actively seeking to build out IT in the context of contracts with an expanding number of health care organizations and payers. As the U.S. health care system shifts to accommodate population management and value-based models of care, the need to link multiple data streams across community-based organizations, medical providers, and individuals is increasingly salient and pressing. Therefore, the report discusses how and why AAAs may wish to bolster their IT capacity, and provides recommendations for next steps.

## Release of 2015 Health Insurance Estimates for All Counties and States

The [2015 Small Area Health Insurance Estimates \(SAHIE\)](#) are available on the U.S. Census Bureau's Web site. The SAHIE program provides single-year estimates of health insurance coverage for every county in the U.S. Resources available include an [interactive tool](#) that allows data users to create, download, and share custom data tables, maps, and time trend charts. The [2015 SAHIE Report](#) provides an overview of the latest release and a comparison with the prior release. A [Health Insurance Data Source Recommendations chart](#) summarizes guidance for data users regarding Census Bureau health insurance coverage datasets. ## Centers for Medicare and Medicaid Services

### February 2017 Monthly Report on State Medicaid and Children's Health Insurance Program (CHIP)

CMS has released the February 2017 monthly report on state Medicaid and Children's Health Insurance Program (CHIP) eligibility and enrollment data. The report contains preliminary data and includes data for all states on the following indicators:

The number of applications submitted directly to Medicaid and CHIP agencies, including those received through State-Based Marketplaces (SBMs);

The number of eligibility determinations made by Medicaid and CHIP agencies on the applications described above, as well as applications to the Federally-Facilitated Marketplace (FFM) in states for which the FFM makes an eligibility assessment (and the state then completes the Medicaid or CHIP determination); and

The total number of individuals enrolled in the Medicaid and CHIP programs who are receiving comprehensive benefits, including details on the total number of children enrolled in these programs.

## Consumer Financial Protection Bureau

### What to Do If You're Wrongfully Billed for Medicare Costs

Consumer Financial Protection Bureau (CFPB) has partnered with CMS to issue three tips for those enrolled in the Qualified Medicare Beneficiary Program (QMB) program to respond to bills for Medicare cost sharing and debt collection attempts. Medical providers are not allowed to bill those individuals enrolled in the QMB program for Medicare deductibles,

coinsurance, and copayments.

### Senate

#### **Aging Without Community: The Consequences of Isolation and Loneliness**

On **April 27th, 2017**, the U.S. Senate Special Committee on Aging held a hearing on "Aging Without Community: The Consequences of Isolation and Loneliness." The Committee is chaired by Senator Susan Collins (R-ME), and Ranking Member Senator Bob Casey (D-PA). Social and physical isolation of older adults is increasingly being recognized as not only a social issue, but also a health one. Social isolation can lead to a multitude of poor health outcomes, hospitalizations, emotional and psychological distress, among other poor individual outcomes. Older adults residing in rural or frontier communities are at particular risk of experiencing social isolation and loneliness. Four esteemed witnesses provided testimony at the Committee hearing, including:

- Julianne Holt-Lunstad, PhD, Brigham Young University.
- Lenard W. Kaye, DSW, PhD, Professor of Social Work and Director of the Center on Aging, University of Maine.
- W. Mark Clark, MSW, President and CEO, Pima Council on Aging.
- Rick Creech, Educational Consultant, Pennsylvania Training and Technical Assistance Network.

The Senate Special Committee on Aging will be holding an additional hearing on **May 10, 2017**, on "Aging With Community: Building Connections that Last a Lifetime."

## Avalere Health

### Medicaid Per Capita Caps Could Cut Funding for Dual Eligible Beneficiaries

On **April 20, 2017**, Avalere Health released a report that analyzed the potential impacts of Medicaid per capita caps on dual eligible individuals, or those that are jointly eligible for both the Medicare and Medicaid programs. Dual eligibles typically have some of the highest care needs and costs within the healthcare system, and also frequently require long-term services and supports (LTSS). Medicaid per capita caps are included in the proposed legislation to repeal and replace the Affordable Care Act (ACA), known as the American Health Care Act (AHCA).

The analysis from Avalere notes that capping Medicaid funding could lead to a \$44 billion reduction in funding for dual eligible beneficiaries over a ten-year period. The report also notes that, in the long-term, per capita caps could also shift costs to the Medicare program, even as funding would decrease for Medicaid.

## Center for Health Care Strategies

### Webinar: Community Paramedicine: A New Approach to Serving Complex Populations

Health care delivery systems are increasingly incorporating alternative roles into care teams, including community health workers, volunteers, neighborhood navigators, community paramedics, or pharmacists, so that systems can better serve individuals with complex medical and social needs.

This webinar will discuss two community paramedicine programs serving high-need patient populations in Wisconsin and Massachusetts. ThedaCare in northeastern Wisconsin will

present about its partnership with Gold Cross Ambulance Services to launch a community paramedicine program aimed at reducing unnecessary emergency department (ED) visits and expanding access to care for high-risk patients. Commonwealth Care Alliance will discuss its pilot program, Acute Community Care (ACC), and the ways in which it has positively impacted patient care, satisfaction, and outcomes among individuals dually eligible for Medicaid and Medicare. State health officials, providers, health plans and other interested stakeholders are encouraged to join this 90-minute webinar.

## Children's Behavioral Health Care Use in Medicaid

Children in Medicaid with behavioral health needs represent a small percentage of the overall Medicaid child population, but account for disproportionate costs, and are one of the program's most vulnerable populations. These children are often served by multiple public programs, which can put them at risk for fragmented or uncoordinated care. These children often experience poor health outcomes at high costs.

### **ACL Grant: Small Business Innovation Research Program Phase II**

The Federal Small Business Innovation Research Program's (SBIR) aim is to stimulate technological innovation in the private sector, strengthen the role of small business in meeting Federal research or research and development (R/R&D) needs, and improve the return on investment from Federally-funded research for economic and social benefits to the Nation.

More specifically, the program aims to improve the lives of people with disabilities through R/R&D products generated by small businesses, and to increase the commercial application of National Institute on Disability, Independent Living, and Rehabilitation Research (NIDILRR)- supported research results and development products. Phase II is intended to expand upon the results of and to further pursue the development of Phase I projects.

Phase I grantees from fiscal year 2015 and 2016 are eligible to apply. Applicants must also continue to be small business concerns. An estimated four grants will be awarded to small businesses.
