Confronting the Opioid Crisis

By investing more in treatment, mental health services and tools for law enforcement, states have risen to the challenge of combating an epidemic that the Centers for Disease Control and Prevention estimates is responsible for the deaths of 78 Americans every day. The Council of State Governments' National Center for Interstate Compacts developed a compact that was not enacted but was designed to help states share information about opioid abusers across state lines.

2016 State Sales Tax Rates

In 2016, 45 states plus the District of Columbia have sales taxes in place and five states do not. Sales tax rates (or lack thereof) remained the same as 2015 rates in 49 states and the District of Columbia on
