SUBJECTIVE: Patient comes in today with his wife.

He was dizzy in the mornings for about a week. He actually went and saw Dr. Seabrook last week in regards to possible repeat colonoscopy. It is interesting because at that time he called to be seen, but he is doing better. It was not an emergency or anything such as that. Today he is better. It was transient and may have been allergy-related, etc. We talked about his wife who went and had an evaluation by Dr. Baugh. She, in fact, does not have any coronary artery disease. Patient is due to go back and see Dr. Amory and we talked about his heart. He feels pretty well. I think it is difficult for him to take care of his wife as much as he is doing. I think that she may be headed for an extended care facility, as he is still rather spry. He works extremely hard to keep her straight and does a good job of it.

He is on his antihypertensives and his diabetic medication and does quite well. He was here for a physical examination in April and, in fact, his hemoglobin A1C was 5.9. His LDL cholesterol was too high at that point. We had talked about increasing his Lipitor at that point, too, but I think he may have had problems with increasing Lipitor in the past. He denies any new chest pain, shortness of breath, blood in stool, black stool, headache, nausea or vomiting.

OBJECTIVE: BP 142/82, HR 68, Wt 203 lbs. CV: Heart with RRR, without audible MRG.
ABDOMEN: With positive BS, NT/ND, no HSM. EXT: Show no cyanosis, clubbing, cord or edema.

ASSESSMENT & PLAN: Pleasant gentleman with coronary artery disease with increased lipids at last check. However, on the same medicines in the past they have been quite low. I wonder if that was an aberration that needs to be rechecked when he is fasting before we increase his medicine. He also has history of parkinsonian syndrome without true Parkinson's disease, history of recent vertigo, history of extreme environmental stressors with his wife. I told him that he and I need to talk about what we need to do in regards to long-term placement for her.

He will come back in about six weeks.

SUBJECTIVE: Patient comes in today for follow-up of his medical problems. Since we have seen him last, he has been doing okay. We spent about 30 minutes together talking about things, in general.

He had a physical here in March at which time his cholesterol was elevated. We wanted to bring this down, particularly with his history of coronary disease. He is on Lipitor now and I believe Dr. Amory has increased the dose in the interim. We will repeat it, as well, when he comes back next time. He denies any new chest pain, shortness of breath, blood in stool, black stool, headache, nausea or vomiting. His mood is better. He still has some orolingual dyskinesia, thought to be related to his prior use of Reglan, but it never really wore off so he still carries the diagnosis of Parkinson's, as well. His heartburn is under control. I have given him plenty of samples for both him and his wife today.

OBJECTIVE: BP 112/64, HR 76, RR 16. CV: Heart with RRR, without audible MRG. LUNGS are clear. ABDOMEN: Benign. EXT: Show no cyanosis, clubbing, cord or edema. He does have some choreiform movements of his trunk.

ASSESSMENT & PLAN: Pleasant gentleman with history of diabetes always under good control, hyperlipidemia, and coronary artery disease. I would not make any changes today, other than to see if we can get the last lipids from Dr. Amory, as he is going to need them repeated. We have been reluctant to do a lot with his medications in the past because of perceived side effects that he had, but his LDL needs to be under 100 and possibly under 80.

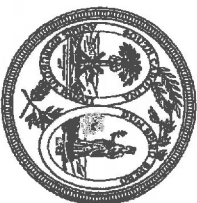
