Your Freedom of Information Act request dated July 29, 2014 was referred to me for processing. You requested the following information:

1. The total number of licensed, practicing Physicians (MD &DO) accepting Medicaid in South Carolina.
2. The total number of licensed, practicing Primary Care Physicians (MD & DO) accepting Medicaid in South Carolina.
3. The total number of licensed, Practicing Specialists (MD &DO) accepting Medicaid in South Carolina.

There are 11, 267 licensed practicing physicians that are in enrolled in South Carolina Medicaid. However, please note that being enrolled does not mean that the physician is currently accepting South Carolina Medicaid. The South Carolina Department of Health Human Service (SCDHHS) does not track if a physician is enrolled, but not accepting Medicaid in South Carolina.

There are 4,366 licensed practicing Primary Care physicians that are enrolled in South Carolina Medicaid. As previously noted, the fact that the Primary Physician is enrolled in South Carolina Medicaid does not mean that the Primary Physician is currently accepting South Carolina Medicaid. Primary Care physicians are categorized as follows:

- Family Practice/1,789, General Practice/90, Internal Medicine/1,624, Obstetrics/7 and Gynecology/19).
- Pediatricians (Pediatric/829, Pediatric Allergy/2, Pediatric Cardiology/6)
