Dear Governor Haley:

Back in 1775, British solders had general writs which allowed them to search anyone's house at any time. NSA contractor, Edward J. Snowden, revealed that back door spy programs could be placed on a personal computer either at the factory or in transit at Fedex Ground or UPS. These programs can allow a police officer to spy on your email, web use, or individual applications such as word processors, back up programs, etc. I suspect that they can be put on your personal computer via a Microsoft Windows update. Once the program is installed on your computer, it immediately informs them of your actions.

Enclosed is a copy of my letter of January 11, 2016 to Nassau County Executive, Edward Mangano. Did a member of the Nassau County police

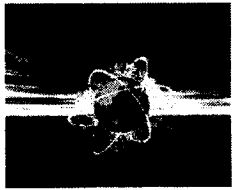
department enter my apartment in my absence and install a spy program on my new computer? Does this software allow certain neighbors (such as the people who live at 190 West Nicholai Street, Hicksville) to watch what I am doing on my personal computer and holler on the street about it? On page 5 of the letter, I inquired about the use of a spy camera inside my apartment. Did a member of the Nassau County Police Department install a spy camera inside the smoke alarm in the hallway of my second floor apartment at the juncture of the doors to the bathroom, bedroom, and kitchen?

Governor Haley, I want you to support me in my request that the Nassau County Police Commissioner supply answers to my questions about who is using the internet to spy on my personal computers and home telephone. I suspect that immoral police officers are racketeering behind the scenes and need to be terminated. In addition, I want to be told how to remove the spyware program from my new personal computer, my old personal computer, and my notebook computer.

Dear Nassau County Executive Mangano:

I want your help in getting information from the police commissioner of the Nassau County Police Department about the improper use of police power by out of control police officers.

I live in 2 rooms on the second floor of a small cape type house at

199 West Nicholai Street
Hicksville, New York 11801.

Whenever I leave, I lock the lock in the door knob of each room and a padlock on a hasp attached to each door. My landlord, Mariola J. Tallman, lives on the first floor of the house. I never gave her the keys to the locks on the doors of my room or the combination of a combination lock on one of the hasps. In addition, I change the keys and padlocks from time to time.

However, recently some one entered my apartment in my absence on at least 3 occasions.

In order to use my old desktop computer, I had to insert a small circular key into a circular key hole on my computer and twist it clockwise. I kept 2 computer keys in a red tool box nearby which was locked with a padlock. The key to the padlock was in the top drawer of my bedroom bureau.

On September 21, 2015 as I walked out the door of my house, Mariola Tallman said in her first floor living room, "You put in an optical drive." She was correct. On September 20, 2015, I did install a CD ROM drive into the frame of a new desktop computer which completely bare except for the cooling fans. On October 11, 2015, I discovered that the tab on the tip of both computer keys was broken off so that I could not turn my computer on. As I walked out the door of the house, Mariola Tallman said in her first floor living room, "He must of found out that we broke the keys."

On Saturday, December 19, 2015, motorists drove by my place of employment hollering that "they" entered my apartment in my absence. Who entered my bedroom and for what purpose?

For months, I noticed that a few people on West Nicholai Street hollered my personal business on the street. They were able to spy on my email and Internet use. Police officers knew what I did on my personal computer and would shout it from a vehicle which had a siren blaring as they drove near my house. In fact, this was the subject of my last letter to the Nassau County Legislature on August 14, 2014. In addition, within 3 hours after I mailed a letter in a 9" X 12" envelope (or larger envelope) in Manhattan, motorists drove by my home quoting parts of it. I suspect that some one spied on letters which I wrote on my word processor. Perhaps they spied on my computer's "Documents" file or "MY Documents" file. In addition, police officers or motorists passing near my home or place of employment hollered from their vehicles details about the custom features which I designed and built for my new desktop computer. I may have invested between 40 to 100 hours of my time doing research and thinking about the problem before coming to a detailed solution. I do not want anyone engaging in knowledge stealing or theft of intellectual property by entering my apartment in my absence for this purpose.

On the evening of December 20 2015, I changed the SSID and password for my computer's router. About 30 minutes later, I heard a female motorist holler as she drove past my apartment, "He changed

his router's address." Other motorists hollered about this as they drove past my apartment. One woman hollered, "We'll get the new password from the big envelope that he keeps it in." [She was correct. I kept all email passwords, router password, and Internet passwords in a 9" X 12 " vanilla envelope in my bedroom. It was hidden beneath a pile of store catalogs in the corner of my bedroom.]

On January 3, 2016, I changed my email password. A few minutes later, some one hollered on the street outside my home that I had done this. She said that the police would contact Microsoft to find out the new password.

I want you to ask the Nassau County Police Commissioner to find out and report to you the following information. Did a member of the Nassau County Police Department enter my bedroom on December 19, 2015 or at any other time in the past year in my absence? Did they obtain the password to my old computer by connecting a device to the keyboard input of my old desktop computer or by any other means? Did they obtain the password of my SSID, email accounts, and other Internet accounts from the 9" X 12" envelope in my bedroom which contained this information? Who did they give the passwords to? Did they install a software program on my old desktop computer or my

new desktop computer which enabled them to view letters which I typed on my computer or the contents of the "Documents" file where I store all my letters? Did they download computer files from my back up hard drive which is near my desktop computer? Did they talk to Mariola Tallman and ask her to keep tabs on me and report to a police officer the personal information so obtained? Did they supply Mariola Tallman with a core remover to enable her to enter my apartment in my absence? Did they supply Mariola Tallman with a sensitive listening device such as a parabolic microphone so that she can spy on me? Did they supply Mariola Tallman with a spy camera which can penetrate plaster and wooden walls so that she could see what I was doing? [This might explain how she knew the password to my personal computer, the location of the key to my computer, and the location of the envelope containing passwords.] Was Mariola Tallman ever paid for her services as a police informer? If so, how much was she paid? Is any member of the Nassau County Police Department in contact with Mariola Tallman at present? What is the nature of this contact?

I want the Nassau County Legislature to obtain the answers to the questions above and send a copy of the police commissioner's response to me by registered mail or certified mail by March 15, 2016.

If I do not receive a response by that time, I will assume that one or more members of the Nassau County Police Department entered my apartment in my absence for the purpose of tampering with my personal computer, obtaining passwords so that my personal computer use could be spied on in an immoral and cowardly manner, and used Mariola Tallman as a police informant equipped with spy devices.

Mr. Mangano, the policemen of Nassau County do not have an inherent right to persecute anyone to death the way that they have done to me for 32 years. I have a right to know who is entering my apartment in my absence, for what purpose, and to take all necessary steps to defend myself from abuse and persistent persecution.
