

MINUTES OF BUDGET MEETING

October 5, 1945.

The Budget Commission met in the Governor's Office at 11:00 o'clock A. M., October 5, 1945. All members of the Commission were present.

The following appropriation transfer was approved by the Commission:

Superintendent of Education's Office

From Item 3 - Assistant - Alcoholic Education \$187.50  
Item 3 - Stenographers \$212.50 -

To Item 7 - B-2 Conference Travel.

The following allotments were made from the Civil Contingent Fund:

Governor's Office

Travel for Industrial Agent, through October, 1945, \$200.00

The Commission declined to approve the use of any of the appropriation made to the Department of Education for "Special Education of Hard of Hearing Children" for any other category of handicapped children. It was pointed out that the appropriation was definitely made for the education of hard of hearing children; and that the Commission was without authority to divert any of this fund to any purpose not contemplated in the appropriation.

The request from the South Carolina Association of Real Estate Boards, for a contribution of \$2500.00 for the publication of a book on South Carolina, was ordered referred to the State Department of Research, Planning and Development.

The Commission, after consultation with the State Treasurer and Comptroller General, and in compliance with Item 11 of Section 3 of the Deficiency Appropriation Act for the fiscal year 1944-45, ordered the transfer of \$2,638,065.47 to the Post War Reserve Fund.
