My name is Terry Melvin Hughes, I reside at 2512 West Rd. Conway, SC. 29527 .  
On August 29, 2014 I awakened with excruciating pain and was unable to get out of my bed. I was taken to Conway Medical Center by ambulance. The staff did numerous test and found a mass on my spinal cord, which required emergency surgery to remove. I was transported from Conway Medical Center to Grand Strand Regional Medical Center on August 31, 2014; where Dr. Joseph Cheatle performed the surgery to remove the mass. In medical terms it is classed as a spinal tumor , non traumatic spinal cord injury secondary to epidural bleed. I have a history of C2 fracture secondary to auto accident. Resulting from this medical situation I am paralyzed and suffer with Neurogenic bowel & Bladder. I spent weeks in rehab at Carolina Regional Rehab in Charlotte NC. I have to use catheters daily as well as adult diapers. My family is not financially able to help with these things therefore I am in desperate need of assistance. I am including a list of my medications which I am unable to purchase. Medication List:

Ciprofloxacin 500 mg one tablet every twelve hours  
Oxybutynin 5 mg one tablet three times per day  
Enoxaparin 30 mg one syringe under skin every twelve hours  
Bisacodyl 10 mg suppository insert one rectally at bedtime  
Baclofen 20 mg. One three times per day  
14 FR standard catheter kit use as directed  
Omeprazole DR 20 mg one daily before supper  
Gabapentin 400 mg one three times per day  
Hydroco/ APAP 5-325 one as needed for severe pain

Oxycotin 20 mg one tablet every twelve hours  
Lisinopril 20 mg one tablet daily  
Duc-a- lax 100 mg one tablet twice a day  
Senna Laxative 8.6 two tablets daily
