

# - ASKEWGATE -

Nelson had set up and masterminded the crime. They arrested him five years later and he pleaded guilty - See Exhibit #2. But when the prosecutor was unable to place me at the scene, he had the newspaper print that I set up and masterminded the crime for the jurors to read and return a guilty verdict.

# New arrest in 1979 murders of Swarr pair

Nearly 15 years after the robbery and dehydration deaths of elderly Horace and Mary Swarr, Lancaster City and County detectives arrested the man they believe set up the crime.

Donald Wayne Nelson, 58, a well-driller who was romantically involved with the Swarrs' niece by marriage, was arrested in Galax, Va., and charged with criminal homicide on Monday.

His arrest apparently drew to a close one of the county's longest-standing unresolved murders.

The Swarrs were found and gagged in their West Walnut Street house on Sept. 17, 1979, a week after two burglars entered the home seeking money and a coin collection.

Although four were caught and convicted, detectives have hunted ever since for the man they believed masterminded the crime.

When I arrived in Lancaster, I was bewildered when they offered me nine months jail time if I would plead guilty to a minor charge and assist them with the case. Case and point, a guilty plea would have whitewashed the crimes that they perpetrated in conspiratorially arresting and kidnapping me. When I refused the deal they quickly moved me to the Lebanon County Jail, 45 miles away, for the sole purpose of transporting me back and forth to Lancaster in a four-door car with functional inside door handles, no leg restraints, and making a dozen unnecessary stops to provide me an opportunity to flee, so that they could kill me. There would wind up being six attempts to assassinate me while in Lancaster County's jurisdiction.

Upon holding my preliminary hearing absent probable cause, my crooked attorney [Public Pretender] Edward Browne, who was conspiring with A.D.A. John Kenneff and District Justice Vickie Bomgardner, ran into a problem halfway through the hearing when they failed to establish probable cause. Browne jumped up and falsely told Bomgardner that she would have to halt the hearing because I was ill. When I returned three weeks later, I noted that they had altered and falsified the transcripts by placing me at the scene of the crime. They then unlawfully had me bound over to the kangaroo trial court of the notoriously corrupt judge, Michael J. Perezous, where all court officers engage in conspiratorial plots to rig trials to have guilty verdicts fraudulently rendered. When Kenneff failed to place me at the scene of the crime, he defrauded my trial as well as the jury when he assured the jury that I was "as guilty as the men who did the crime, even if I never left the state of Maryland.", but Kenneff couldn't say that, when I wasn't on trial for conspiracy. His co-conspirator, Perezous, looked the other way, among other issues, wherefore he omitted his signature from the transcripts, because he allowed Kenneff to alter and falsify them.

When Browne got caught in the conspiracy at my P.H., he resigned. However, when I told him that I was going to report him to the F.B.I., he laughed and assured me that I would be wasting my time. How true!

Upon filing a formal complaint with the F.B.I. for the first time, Special Agent Raymond L. Meese initially contacted me on March 29, 1989. When I presented the array of evidence substantiating the conspiracy to unlawfully arrest, kidnap, and deny me Due Process of Law, he merely said, "Well, there's nothing we can do right now. Call me after your trial." Note where Chief M. Landis fears that they may be busted and attempts to sell the conspiracy to deny Due Process, as a mistake - See Exhibits #3 and #4.

With the F.B.I. on Lancaster County's payroll, the L.C.C.J.S. was very concerned over seizing me absent probable cause or an arrest warrant, so they merely had the F.B.I. perpetrate fraud, false entry, and mail fraud, when they mailed a letter to U.S. Senator Connie Mack, dated March 5, 1996, falsely alleging that "They interviewed me at the Somerset County, Maryland jail", so they could testify later, if needed, that they actually reviewed an arrest warrant, taking the L.C.C.J.S. and M.S.P. off of the hook. I was only at the Maryland jail for five days and never called or wrote the F.B.I. or saw them - See Exhibit #5. Obviously, the F.B.I.'s Washington office was not aware that their Philadelphia office had already written me the letter dated May 17, 1989. Busted!

John Askew, a Maryland man convicted in 1989 of second degree murder in the killings of Horace and Mary Swarr, has written to Dalzell, saying, "The Lambert evidence, coupled with the irrefutable material I have provided would represent a sound case for the U.S. Attorney to prosecute."

Askew claims to have proof of wrongdoing by Assistant District Attorney John Kenneff.

Chief Michael Landis of the city police said he's not surprised at Askew's allegations, since Askew has claimed all along that he was framed. But Landis is disturbed at the trend, both because he believes the system is already overburdened with appeals, and because a microscope directed at any one case is bound to turn up mistakes by the police or prosecution.

"We are no different than anybody else," he said. "We're human beings and we're going to make mistakes."

# Hearing unfair

John A. Askew, a suspect in the Swarr murder case, has filed a complaint in federal court alleging that his former attorney and other officials conspired to deny him a fair pre-trial hearing.

The handwritten complaint, which Askew filed from Lebanon County Prison, names three defendants: Edward F. Browne Jr., Askew's for-

mer attorney; Assistant District Attorney John A. Kenneff, and District Justice Vicki G. Bomgardner.

The complaint, filed in U.S. District Court for the Middle District of Pennsylvania, alleges that the three defendants acted in concert to stop his Feb. 17 preliminary hearing at the point where a witness' testimony would have "relieved me from these charges."

It also alleges that the transcript of that proceeding was altered to change that witness' statement.

By the time the hearing was resumed March 7, according to Askew, Burkhardt's previous statement had been altered in the hearing transcript.

I had reported the public corruption in Lancaster County to Pa. FOOTNOTE: Inasmuch as the M.S.P. violated Federal Law, they did not report my unlawful arrest to the F.B.I., which is mandatory!

I am requesting permission to represent John Askew because his case is so compelling that I have very quickly become as obsessed with his case as I was with Lisa Lambert's. Thinking about the injustice that this poor man has suffered keeps me awake at night, and I can think of little else. I believe, quite strongly, that this is a wrongful prosecution case on a par with Lambert's, and that the damages that would be recovered from a subsequent civil case.

Now, the details. John Askew has written me repeatedly asking for my assistance. He has claimed, since long before the allegations in the Lambert case came to light, that he was framed by the same assistant district attorney who framed Lisa Lambert - John Kenneff. In addition to Kenneff, two officers who are known to us as "bad cops" from the Lambert case played key roles in Askew's prosecution. John Askew is a married man with 8 children, who was employed by Budweiser in Maryland for 20 consecutive years before he was arrested.

John Askew is serving two life terms, to be served consecutively, for a case which - even if he were involved, which he isn't - isn't even murder. In 1979, some people robbed an elderly couple in Lancaster County and tied them up in their basement. When the robbery was completed, the robbers called 911 and reported that they had just robbed this house and tied up two people in the basement, and that the police had better come and rescue them or they would starve to death.

The police never came. They claimed the robbers had given them the wrong address, but I do not believe that there was any evidence to support their claim. The Couple starved to death. The crime went unsolved for ten years, then in 1989, Kenneff pinned it on Askew and two others. Askew was tried first. By the time the last defendant was tried, the "evidence" had changed so dramatically that it was clear that Askew was innocent.

Askew is desperate for us to represent him. He believes that there is no one else who can uncover what really happened, and I agree. Unlike any other Firm; we know how Kenneff works, we know how officers Barkley and Geesey work, we know where to look for hidden evidence, and we know how to catch them.







"A pretext for war", by James Bamford: "From January 2003 on, there was a great deal of pressure to find a reason to go to war with Iraq." "This war's going to happen regardless", a senior C.I.A. official wrote.

"There was a lot of stress", the president said. "Yeah, I felt stressed." All of the holiday parties at the White House added to the difficulties at the end of 2002. "My jaw muscles got so tight. And it was not just because I was smiling and shaking so many hands. There was a lot of tension during that last holiday season."

Then on either the Thursday or Friday after New Year's, Rice had a private moment with the president. "Time is not on our side here", Bush said. "Probably going to have to, we're going to have to go to war." In Rice's mind, this was the president's decision on war.

John A. Askew, a Pennsylvania inmate, commenced this Action - Motion for a Temporary Restraining Order and Preliminary Injunction. According to Askew, in 2000 then Presidential Candidate, George W. **LONDON** — A meeting between former President George W. Bush and Prime Minister Tony Blair a full year before the 2003 invasion of Iraq marked a turning point in the march toward war, Britain's former ambassador to the United States testified Thursday.

Giving evidence on the third day of an independent British inquiry into the war, Christopher Meyer told the six-member investigating panel that Blair's stance on Saddam Hussein appeared to shift after a meeting between the two leaders at Bush's ranch in Crawford, Texas, in April 2002.

"I'm not entirely clear what degree of convergence was signed in blood at the Crawford ranch," said Meyer, who served as Blair's ambassador to Washington from 1997 to 2003.

**Testimony in England cites a key meeting**

But he interpreted Blair's hard talk on Iraq in a speech days after the meeting as "a tightening of the U.K.-U.S. alliance and a degree of convergence on the danger that Saddam Hussein presented."

Referring to Iraq and the need for the West to act on Saddam's noncompliance to international pressure, he said, Blair used the term "regime change" for the first time.

London Mayor Ken Livingstone, who on Monday called Bush "the greatest threat to life on this planet that we've most probably ever seen," urged anti-Bush demonstrators to remain peaceful. "You are protesting against an illegal war and occupation, and the world will be watching you," he said.

The investigation is the most sweeping yet into the war by any of the nations involved. It is expected to consider allegations that Blair secretly backed President George W. Bush.

Britain's role in the Iraq conflict, which triggered massive public protests at home, left 179 British soldiers dead.

"Tony Blair consistently denied to Parliament and public

that the U.K. government was preparing for war in Iraq, yet these documents show that planning began as far back as 2002," Alex Salmond, leader of the Scottish Nationalist Party, said yesterday. The revelations prove Blair took Britain into "an illegal and disastrous war on false pretenses," Salmond said.

In his book, The Greatest Story Ever Sold, Frank Rich wrote: "A question remains unanswered: Why did the Administration push and push so urgently for a war in Iraq after the summer of 2002?" Answer: Because Askew tipped off U.S. Senator Tom Daschle on 9/19/02, by Certified Mail (7009 3400 0012 4576 6270), that "The Bush War Conspiracy" was in motion, solely to "wag the dog's tail". Daschle tipped off Bush that I was on to him, so Bush again, in desperation, had the Department of Justice (D.O.J.) write me a letter dated 10/9/02, to try again to draw feedback from me – See attached including excerpts from authors, Bob Woodward, James Bamford, and Frank Rich, and Exhibits at #12.

On or about 12/12/02, Bush attempted to have me transferred so that he could have me killed en route to another prison, since it was no longer feasible to carry it out here. I thwarted his plan by quickly filing a Restraining Order (R.O.) and Preliminary Injunction (P.I.) against Bush on 12/16/02. Acting in a conspiracy to cover up for Bush, Judge Samuel Alito deemed my R.O. and P.I. frivolous. Bush would later reward him with a seat on the Supreme Court. Alito's criminal conduct paved the way for Bush to attack Iraq and make further attempts to kill me – See Exhibit #13.
