The South Carolina Department of Alcohol and Other Drug Abuse Services (DAODAS) is requesting an adjustment in the amounts enumerated under Article IV (Conditions for Reimbursement by SCDHHS) in Contract A201411076A (Purchase and Provision of Access to Alcohol and Other Drug Addiction Treatment and Recovery-Supported Services and Improvements in Treatment Quality).

This adjustment is requested under the provision of the contract that stipulates "the amounts enumerated above may be adjusted with approval of the Director of SCDHHS and the Director of SCDAODAS."

Due to the serious issue of prescription drug abuse in South Carolina, DAODAS is requesting authority to move \$100,000 designated for grants to improve service engagement to a new specific designation of \$100,000 to address the problem of prescription drug abuse. The revised reimbursement language would read as follows, with revisions underlined:

SCDHHS shall reimburse SCDAODAS during the term of this Contract an amount to be based on SCDAODAS' actual allocable, reasonable and necessary documented cost not to exceed Three Million Dollars (\$3,000,000) with Eight Hundred Thousand Dollars (\$800,000) being used for implementation of Electronic Health Records; One Hundred Thousand Dollars (\$100,000) being used for statewide training and professional development; One Hundred Thousand Dollars (\$100,000) being used to address problems related to prescription drug abuse; One Million, Four Hundred Thousand Dollars (\$1,400,000) being designated for grants awarded through a competitive grant application process for the provision of particular service sets; Five Hundred Thousand (\$500,000) being designated for grants awarded to provide services that will improve access; and the remaining One Hundred Thousand (\$100,000) being designated for grants awarded to improve service engagement.






