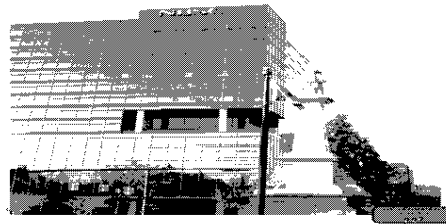

New photos released, taken by Roof of State House's former Confederate flag

Since Dylann Roof was arrested for the slayings of nine black parishioners at a Charleston church, a few photos of the Columbia self-avowed white supremacist with the Confederate battle flag have circulated, taken from Roof's Internet site.

But Tuesday, at Roof's federal death penalty trial, prosecutors introduced numerous other photos of Roof, 22, with the Confederate banner - at antebellum plantations, at the house where he was staying and, most prominently, at the S.C. State House. **Roof's undated photos included one of the Confederate battle flag, in a place of honor in front of the State House, with another showing the banner flying in the breeze.**
