Senator Young –

Again my sincere thanks for the updated important information that you provide on such a timely basis. I look forward to each 'issue'!

My question regarding the SCDOR relates to a comment in the recently received "SCDOR Data Breach" letter. In the first paragraph an underlined sentence reads as: **We are writing you today, first, to confirm that – as an electronic tax filer – your tax information was compromised and, second, to encourage you to take immediate steps to protect yourself against identity theft.**

At the very beginning of this escapade I did take advantage of the offer made by the State of South Carolina, to be an addition to a similar type protective service that I have had in effect for years. However, the above comment in the letter, without further clarification, leaves an unanswered question, unless I have overlooked the answer. The question has to do in the description of a taxpayer having been an "electronic tax filer." There are many taxpayers that have never filed electronically! So, what is the status of a taxpayer who has never used an electronic filing method? In that case is there any concern for a possible security breach without an electronic filing? I believe the question has a

basic germane relationship to the entire scenario.

I will greatly appreciate if someone there could provide an answer to this.
