1. How much do we need to raise your Other Funds authorization by in order to let you expend the pharma settlement proceeds from HHS? It sounds like it's somewhere between \$2.5M and \$3M?
2. Do you have a sentence or two that summarizes your intended use of those funds?
3. For Proviso 25.4, Medicaid Match Transfer, is \$1,915,902 still the dollar amount you want to see, or has it changed?
