A few questions; I know some of these have been answered before, I just want them in one place for this approval:

1. Does PPP only operate re-entry centers in Columbia and Spartanburg? **Yes**

If there are other centers, where are they? **N/A**

2. Does the agency intend to serve the Charleston area in this way again? **Not at this time.**

3. When did the residential centers close? **FY 2009**

Are the re-entry centers in a physically separate place from the residential centers, or did you repurpose the same space for a different mode of operation? **The agency is utilizing the same space for a different mode of operation.**

4. As the agency has received increased appropriations and other revenues over the past few years, is there an intent to prioritize funding for these operations in the near future? **The centers are funded by the revenues the agency generates from Court Fines. The authorization allocated in the Act for the Charleston Center will be reallocated to Spartanburg and Columbia. Personnel Services with associated FTE's may also be realigned from Offender Supervision. There will not be a request in this program for new funding.**

1st Request: In part II B 1. and 3. : A name change from Residential to Re-Entry (1500.150500.000 and 1500.153000.000)

2nd Request: In part II B 2. : Delete (1500.152000.000)

The Re-Entry Centers provide alternative administrative sanctions programs for life skill training and employment for high risk offenders under a highly structured setting without residential services. Due to previous budget reductions, the Residential Centers were not currently operational.
