## SUMMARY REPORT

Meeting of Commission on Higher Education, July 26-27, 1982

Dr. Hugh H. Wells, Seneca, and Mr. Robert L. Wynn III, Spartanburg, have been appointed to the Commission from the 3rd and 4th Congressional Districts, respectively, to four-year terms beginning on July 27, 1982. Mr. Robert C. Gallagher, Charleston, and Mr. Harold W. Jacobs, Columbia, have been reappointed to four-year terms beginning on July 27, 1982. The terms of Mr. J. Clyde Shirley, Belton, and Mrs. Margaret E. Wells, Spartanburg, expired on July 26, 1982.

Act 201 of 1977 (Licensing of Non-Public Educational Institutions to Confer Degrees) provides for licensure by the Commission on Higher Education of non-public institutions which are considered to have met minimum standards. Shaw University, Raleigh, North Carolina, was granted a two-year provisional license on May 1, 1980, to operate in and award the baccalaureate degree in South Carolina. The Commission voted that the provisional license be renewed for one year, expiring on May 1, 1983, subject to quarterly reports with respect to financial matters.

The Commission approved the 1982-83 budget of \$211,324 of the Charleston Higher Education Consortium, as required by a proviso in the 1982-83 Appropriation Act.

The Commission approved (a) a request from Clemson University to expand Clemson Memorial Stadium; (b) a request from South Carolina State College to purchase a portable office building, and to provide an addition and to renovate a building with federal funds; (c) a request from the College of Charleston to effect repairs on a faculty residence; and (d) a request from Lander College for authorization to lease student housing.

The Commission approved a "Position Paper on Increased Minority Representation on College and University Governing Boards."

The Commission approved 1982-83 budget allocations related to the State Desegregation Plan (recruitment and enhancement, graduate incentive fellowships, and monitoring by the Commission), as required by a proviso in the 1982-83 General Appropriation Act.

The presidents of the public senior colleges and universities and the executive director of the State Board for Technical and Comprehensive Education presented their 1983-84 appropriation requests. The Commission will consider the requests at its meeting on August 5, 1982.
