I am writing at the suggestion of the Natural Solutions Foundation, [www.NaturalSolutionsFoundation.com](http://www.NaturalSolutionsFoundation.com), to support my right to truthful speech and expressive association as defined in the First Amendment of the US Constitution.

Natural Solutions Foundation and its Trustees have received a Warning Letter from FDA and FTC because they have shared truthful information about Nano Silver 10 PPM, shown to support normal cell membrane integrity even in the presence of the Ebola virus, in "in vitro" research performed under the US government's Defense Threat Reduction Agency (DTRA) and declassified in 2009.

Further, they have urged that people use Nano Silver 10 PPM for its immune support properties, established by more than 1000 peer reviewed studies.
