Mr. Poore called the meeting to order and Councilman David L. Hooper gave the invocation.

On the motion of Mr. Hooper, seconded by Mr. Gerrard, Council voted unanimously to approve the October 7, 1980 minutes as mailed.

Mayor Davenport approached Council with the request that County Council & all municipalities get together & organize a committee to start working together for the future of Anderson County. He asked Council what their plans were regarding Act #560 (Gasoline Tax Rebate) which went into effect October 1, 1980. Mr. Poore stated that the Council planned to get together with Mr. Dan Guffey, Mrs. Betty Smith and the Anderson County Planning & Development Board. He also asked Council if any decision on the motorvehicle tax had been reached. Mr. Poore stated the Council plans to work on these in the near future and that Council would receive his remarks as information.

Mr. Hurley Badders with the Anderson County Historical Society commented on the good work the County Supervisor had done in getting all the road signs put up. He presented Anderson County with various photographs of the Anderson County Courthouse years ago. Mr. Poore thanked Mr. Badders and promised that they would be displayed in the Courthouse.

Ms. Beth Klosky talked to Council regarding a museum in the City of Anderson. She thought that maybe the County could provide some space in the Bailes Building when it is renovated. Mr. Poore received as information.

Mr. Robert P. Lusk presented a petition and resolution (#113) for application to the State Budget & Control Board for Flowers Industries, Inc. On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted unanimously to adopt Resolution #113.

On the motion of Mr. Hooper, seconded by Mr. Wiles, Council voted unanimously to adopt on first reading Ordinance #60 - \$600,000 Industrial Revenue Bonds for Flowers Industries, Inc.


Mr. Lusk read Resolution #114 (construction or purchase of a water system or systems) and explained its intent. On the motion of Mr. Hooper, seconded by Mr. Wiles, Council voted unanimously to adopt Resolution #114.

Mr. Robert P. Lusk described a road that had been abandoned by the State Highway Dept. and which was actually on the property of Mr. Lake Meredith. The piece of land, approximately 100', runs along I-85 and dead ends on Mr. Meredith's property. On the motion of Mr. Gerrard, seconded by Mr. Hooper, Council voted unanimously to complete the necessary work to return this piece of property to Mr. Meredith, since it would be of no use or value to the County.

Mr. Calvin Barnette of the Anderson County Planning & Development Board, asked County Council to sign a resolution (#115) which would allow his department to begin work on a \$450,000 Community Development Grant for Susan, Booker and Revere Streets. On the motion of Mr. Wiles, seconded by Mr. Hooper, Council voted unanimously to pass the Resolution.

On the motion of Mr. Hooper, seconded by Mr. Gerrard, Council voted unanimously to adjourn at 7:55 p.m.
