We haven't seen anything to suggest that Attorney General Alan Wilson deliberately withheld information from the public when he failed to list nearly \$70,000 worth of donations and expenditures in his 2010 campaign to become the state's top prosecutor. Unlike other cases, where elected officials have gone to great lengths to hide or misrepresent donations, this case strikes us as precisely what Mr. Wilson's campaign says it was: shoddy record keeping. And it's to his credit that rather than simply report the donations he realized had gone unreported after being questioned by reporters, he hired an independent accountant to review nine months worth of records.
