The font sizes should follow the ones in the draft version. I used Century Gothic font. The header font is size 48 bold. The three lines below that are 18 regular. The date line is 20 bold. And the last line is 18 regular again. All text and the Heritage Means Business logo should be centered in the white space to the right of the photo and plaid border.

Amy would like for BFG to create a high res version of this – suitable for the type of printing I've mentioned above.

She's also asked how quickly they can turn this around and get it back to us. She would like it done as quickly as possible so we can have the cards printed.
