

GOVERNMENT RELIGIOUS PERSECUTION – *State officials hate tolerance and diversity – only homosexuals and those who praise them are welcome in state and federal government workplaces. Christians have been attacked by, in your face homosexuals, their lawyers and wicked judges; resulting in them suffering great financial loss and having their businesses destroyed. Forcing Christian, by law, to honor the homosexual lifestyle or lose their livelihood is, an oppressive use of authority. Forcing a Christian to participate in a homosexual wedding is an attack on their religious conscience. Deuteronomy 19:17 "Rebuke your neighbor frankly so you will not share in his guilt." Firing state workers because they disapprove of homosexuality is evil; because the motive is to force honor and respect for what God calls evil, Leviticus 20:13.

If homosexuals are not required to respect and honor a Christians concept of sexual morality by law; then why make laws that force Christians to honor and respect the homosexual lifestyle, or be attacked in the courts. Was - Religious Persecution - the original intent of lawmakers? Freedom of sexual orientation, as law, promotes, and protects every imaginable sexual prevision. The same law should also protect a Christians religious understand of "freedom of sexual orientation" or there is no "freedom." Most judges today ignore this – obvious possible - interpretation of the same laws in their zeal to attack Christians, pander to liberals and promote homosexuality.

To attack a Christians understanding of their religious concept of sexual morality and then promote a homosexuals concept of sexual morality is unequal treatment under the law. Homosexuals are free to promote and live their sexual lifestyle but Christians and those who do not approve of homosexuality are not free to live and promote their sexual lifestyle.

Church leaders, especially those who are on TV, and many other that are invited to be interviewed by media personalities, should use those opportunities to publicly call on our President and Legislators to repent and revoke laws that promote homosexuality.

If our president and lawmakers are so in love with, men who have sex with men and then shout it from the house top, that they will not repent and revokes laws that promote homosexuality. Then, insist that legal protection be provided by, petitioning our lawmakers to establish another law that specifically gives Christians and God fearing Americans the right to act and promote their religious or traditional understand of "sexuality orientation."

**Discrimination:** If two men go to a bakery and request a cake be made for their wedding and the baker refuses, they can go to another bakery; many bakers would be willing to serve them and take their money. Some homosexuals discriminate against Christians by deliberately assaulting Christian owned business with their demands for respect and approval of their homosexuality.

Wicked judges have given homosexuals the right to discriminate and attack Christians and anyone who does not approve of their sexual perversion. Those who approve of men having sex with men or women doing the same, are perverts themselves. They will be numbered among them and condemned of the Day of Judgment; John 5:28-29.

**Equal treatment** under law is a two-way street and must include opposing - sexual views and lifestyles; this would enhance freedom. As the law is enforced now, only homosexuals have "freedom of sexual orientation"; and that is not freedom. Effectively today, the most important qualification one needs to obtain a government job is: being a homosexual or applauding and praising homosexuals.
