On page 4, where we discuss the level of support, I think we can probably make a bolder statement in terms of the executive sponsorship for this initiative – this should hopefully help our application a little. So I'd replace the current passage on my title/role with this:

Christian Soura, Deputy Chief of Staff to the Governor for Budget and Policy, is the author of South Carolina's annual Executive Budget and has actively participated in the efforts of the Department and
