Holly,

In addition to the four bills I sent you yesterday (S.150, S.600, S.550, and H.4641), I found three bills that would restructure one or multiple aspects of our health agencies:

1. S.768, which would put DMH autism programs under DDSN, and would make DDSN a cabinet agency;
2. H.3079, which would take the Division of Children, Adolescents, and Families from DMH and put it under the newly created Department of Child and Family Services; and
3. H.4105, which would split DHEC into the Department of Health and the Department of the Environment.

I hope this is helpful.

I found 48 filed bills that contain the term "health and human services" (<http://www.scstatehouse.gov/query.php>), and 51 filed bills that contain the term "human services" (<http://www.scstatehouse.gov/query.php>). I only read those bills that, based on their short description, seemed like they could possibly contain restructuring language (ex. I did not read the SC Fair Tax bills even though they contained the words "health and human services"). Based on my search, I only found two bills filed this session that would restructure HHS:

1. S.150, which would remove public welfare programs from DSS and place within HHS; and
2. S.600, which would abolish DDSN and place within HHS.

Companion bills S.550 and H.4641 create a new Department of Behavioral and Public Health, but this only affects DHEC, DMH, and DAODAS. Nothing new is placed within HHS.
