Description

The Patriots Point Athletics Complex contains the College's baseball, soccer and softball facilities. This project was established in January 2005 to upgrade the facilities at Patriots Point. The baseball facility has an inadequate number of and poor quality seating and the back-stop net is on poles further into the field, which severely restricts the sight lines. The baseball upgrade includes new covered seating (539 stadium seats, 296 benches with backs, and 20 ADA/companion seats), a connector to the existing building that will extend forward creating a new press box, and a new back stop net. The softball upgrade includes putting a cover over the seating and a new back stop net. The soccer upgrade includes putting a cover over the seating. The total cost of the project is estimated to be \$3.5 million.

The College is adding \$100,000 in excess debt service and \$1.5 million of the proceeds from the sale of Remley's Point. The legislation granting approval of the Remley's Point sale stipulated the proceeds were to be used by the College of Charleston for athletic, intramural, or sports programs. The property was sold in 1997-98 and the proceeds are being used by the College as required by law (§ 59-130-35, SC Code of Laws).

Recommendation

Staff recommends approval of this project as proposed.

Description

This project is to replace two air handlers in the Clinical Sciences Building that are beyond their useful lives. These units service the 8th and 9th floors. The two units will be replaced with a single unit that provides system redundancy and improves operating efficiencies.

There will be no change in annual operating costs/savings due to this project.

Staff recommends approval of this project as proposed.

Description

This project is to renovate the 7th floor of the Basic Sciences Building to accommodate agent containment needs and will support bio-defense and other biomedical research using infectious agents that require high-level containment. The 1,773 square feet of space will be renovated into an integrated high-level bio-containment research facility.

The project was established in July 2004 with federal grant funds and indirect cost recovery funds. The initial budget of \$1.3 million was developed by cost estimators under contract to the University. The University received good bid competition but the lowest bid was substantially over budget. The major expense in this project is driven by the required mechanical systems. Several different mechanical bids were submitted and there was not much variance. The initial budget estimate was grossly understated due to the following reasons: recent construction and materials cost increases; a very difficult work space given contiguous spaces which must remain in use during the renovation; a relatively small project preventing economies of scale; lack of a lay-down area; and the need to bring equipment in via crane through roof penetrations that will have to be cut and later rebuilt.

Recommendation

Staff recommends approval of this project as proposed.

Information Items

MUSC has notified the Commission of its plans to sell property located at 170 Ashley to the University's Health Science Foundation. The property is in very poor condition and requires a substantial investment (estimated to be in excess of \$500,000) to bring it up to code before it can be occupied. A recent appraisal set the fair market value at \$250,000.

MUSC has notified the Commission of its plans to sell property in Colleton County. Ten tracts of land were bequeathed to MUSC in 1960 for the purpose of establishing the John Christopher Rich Scholarship. Nine of the tracts were sold and the scholarship established. The one remaining tract could not be sold previously because the ownership was contested. MUSC has worked through legal counsel approved by the State Attorney General's Office and has resolved the ownership issue. A recent appraisal set the market value of this tract at \$221,000.
