Dear Public Safety Coordinating Council:

Please allow this letter to serve as a request from the South Carolina Victim Services Coordinating Council (VSCC) to the South Carolina Public Safety Coordinating Council regarding the VOCA FFY 2015 special solicitation due October 16, 2015. We have grave concerns that the special solicitation is only open to fund Law Enforcement Victim Advocates, Solicitor's Office-based Victim Advocates, and for one-time equipment-only projects and vehicles.

The VSCC is comprised of twenty-two Directors/Administrators who represent a broad range of victim service providers and key stakeholders representing the VOCA statutory priorities of child abuse, sexual assault and domestic violence. Pursuant to SC Code, the VSCC is mandated *"to improve coordination efforts, suggest policy and procedural improvements to those agencies and groups as needed and recommend needed statutory changes to the General Assembly."*

On September 3, 2015 the VSCC discussed concerns regarding the narrow focus of the special solicitation and the need to expand it to **all** victim service providers. Law Enforcement and Solicitor based advocates are generally not qualified to provide the various long-term needs of victims; i.e., therapeutic care, trauma counseling, etc., which is essential to assist victims whose needs surpass those provided by the criminal justice system.

The funds are administered by the U.S. Department of Justice, Office of Victims of Crime (OVC). Guidelines promulgated by OVC are as follows: *"OVC expects that VOCA administrators [SCDPS] will meet with key stakeholder coalitions and groups, including those that represent the VOCA statutory priorities, domestic violence, sexual assault and child abuse prevention, to conduct strategic planning for funding new programs and services, and enhancing existing initiatives."* This has not been done.
