And now I'm being trained in pre-GED. Ms. Haley, I'm not a bad person, only the crime is. I am ready to go home. And even if you must exile me from this state, so be it. Anything for my freedom. At so I'm a old dummy who's messed his life up. But with the life that I have left, I would like to present and show society that I've been broken. I do not have no more trouble in me, I don't have a taste for drugs or alcohol. God has bless me to make it this far and I cannot go back on my word to him. And I want go back on my word with you. Because that is all a man has is his word, and if his word is no good he aint no good. Ms. Haley, there is not a day that go by that I hope the prison officials tell me I'm leaving on the 1st of the month. I humbly ask and pray that you consider my plea for pardon. I'm very sorry for what I did. If I could go back and fix it, trust me, I would. I don't want people to remember the old Charles. I want them to see the new and improved Charles. I'm sick and tired of being sick and

tired Ms. Haley. God knows I am. I would like to take
This time now to say Thank you for reading my letter,
and making an effort of Consideration. Ms. Haley, I really
do ask for forgiveness and Pardon I am sorry. Consider
my accomplishment of The Change I did to make me
be a person of good Character. You can exile me and
make me never step foot back into your state again.
Whatever order you give me I'll do. I want to go
home please.
