### Mental Health Parity Guidance

On January 16, in conjunction with President Obama's announcement regarding the national response to the Sandy Hook tragedy, the Centers for Medicare & Medicaid Services (CMS) released a State Health Official letter on the application of the Mental Health Parity and Addiction Equity Act to Medicaid

managed care organizations, the Children's Health Insurance Program (CHIP), and alternative benefit (benchmark) plans. The State Health Official letter is available [here](#).

## **Health Home Guidance**

Earlier this week, CMS released new guidance on health homes, authorized by Section 2703 of the Affordable Care Act (ACA). Issued as a State Medicaid Director letter, this guidance shares a recommended core set of health care quality measures for assessing the health home service delivery model that CMS intends to promulgate in the rulemaking process.

CMS is not requiring states to use these measures until the regulations are issued, and is sharing the core set to help states as they consider the design and implementation of their health home programs, as well as provide states with enough time to share this information with their health care providers. ## **Proposed Rule on Medicaid, CHIP, Health Insurance Marketplaces**

Also this week, CMS released a notice of proposed rulemaking (NPRM) to provide states with additional information on implementing ACA. Specifically, the proposed rule presents options for coordinating eligibility notices and appeals among Medicaid, the Children's Health Insurance Program (CHIP), and the Exchanges; proposes modifications to existing benchmark benefits regulations for low-income adults; and codifies statutory eligibility provisions and several of the provisions included in the Children's Health Insurance Program Reauthorization Act (CHIPRA). ## **Office of Management and Budget**

### **Guidance to Federal Agencies on Planning for Fiscal Uncertainty in FY13**

On January 14, the Office of Management and Budget (OMB) released a memorandum to federal agencies and departments that provides guidance on planning for uncertainty with respect to FY 2013 budgetary resources, including guiding principles in preparing plans to operate in the event that sequestration occurs. While agencies should plan for sequester, OMB specifically instructs agencies not to implement actions at this time. The memo is available [here](#).

### **Kaiser to Release New Data From 50-State Survey of Medicaid and CHIP Eligibility and Enrollment Policies**

On Wednesday, January 23, the Kaiser Family Foundation's Commission on Medicaid and the Uninsured (KCMU) will release *Getting into Gear for 2014: Findings From a 50-State Survey of Eligibility, Enrollment, Renewal and Cost-Sharing Policies in Medicaid and CHIP, 2012-2013*. The twelfth annual survey examines how a number of states have shifted focus to wide-ranging improvements in Medicaid enrollment processes and systems to begin preparing for 2014 and build on continuing targeted eligibility and procedural changes.

The report provides a snapshot of current policies and procedures and highlights changes states will need to make in the coming year to implement the Medicaid eligibility and enrollment provisions of the ACA in 2014. A second report released at the briefing will highlight the experiences of some previously uninsured people who obtained Medicaid coverage in states that opted to serve the newly eligible population before 2014.

## New Report: A Bridge to Health

This week, the Medicare Rights Center released its latest report, *A Bridge to Health*, which outlines the ways states can ensure seamless transitions to Medicare for beneficiaries who will be covered by private plans through the health insurance exchange created under the Affordable Care Act (ACA) starting in 2014.

According to the report, the ACA creates a streamlined and mostly automated eligibility determination and enrollment process for Medicaid and private plans offered through the exchanges. However, that streamlined process does not apply to people who qualify for both Medicare and Medicaid (also called "dual-eligibles"). In its report, Medicare Rights offers suggestions to states to ease the transition, which include:

- aligning financial eligibility rules across all public insurance programs and the exchange plans;
- simplifying application and renewal rules and processes across all public insurance programs and the exchange plans;
- utilizing electronic data-sharing to automatically verify eligibility and facilitate enrollment into Medicare subsidy programs as an individual becomes eligible for Medicare; and
- using education, outreach, and notices to provide accurate, understandable, and timely information about enrollment obligations, eligibility guidelines, and available benefits.

Medicare Rights also wrote a blog post summarizing the new report, which was made possible by funding from The Commonwealth Fund.
