Governor Nikki Haley News:

The State: SC Transportation Department requests \$5.5 million for building projects

The state Transportation Department wants \$5.5 million in new state money next year, including money to pay for salt sheds, officials told a panel of House members Wednesday. The \$5.5 million requested is less than 1 percent of the \$1.5 billion-a-year in added money the department estimates it will need to maintain and expand the state's crumbling roads and bridges through 2040.

Note: Gov. Nikki Haley and lawmakers have proposed plans to get more money to the Transportation Department. Haley's plan includes lowering by 2 percentage points the state's income tax, which now has a top rate of 7 percent, over 10 years and increasing the gas tax by 10 cents a gallon during the next three years.

A day after satisfying a small screening committee with her vision for leading the S.C. Department of Social Services, Susan Alford passed muster Wednesday with a larger group of senators. The Senate Full General Committee unanimously recommended that Alford, 60, be confirmed as DSS chief, sending her nomination to the full Senate.

Note: Alford, who formerly headed the Youth Learning Institute's Girl's Center at Clemson University, was nominated by Gov. Nikki Haley to replace Lillian Koller.

Note: Initially, some senators voiced dissatisfaction with Haley's selection, saying they had been excluded from the search for a new DSS director, while others questioned her qualifications.

Saying he had cast a cloud over his post as Berkeley County's sheriff, Wayne DeWitt resigned Wednesday, more than a month after his drunken driving arrest. DeWitt, who had served as sheriff for 20 years, had resisted community members' calls for him to step down after the ordeal Dec. 28, when his county pickup was seen speeding from a police car at 108 mph after he fled from a crash site.

Note: Haley accepted DeWitt's resignation and responded by writing in a letter that his "seat shall be filled in the manner according to law." She has the authority to appoint his replacement until a special election can be held.

North Carolina is heading for a serious teacher shortage, judging by the number of students enrolled in UNC education programs. It's down 27 percent over four years. UNC system schools produce a large share of North Carolina public school teachers. The decline translates to thousands fewer classroom instructors. Where will they come from?

Note: In South Carolina, Republican Gov. Nikki Haley has proposed: tuition subsidies for college students who agree to teach for two years; help in paying college loans; financial support for teachers earning graduate degrees; and extra pay for teachers who agree to mentor younger colleagues. North Carolina should match those initiatives.
