

## **Open Enrollment**

*This year, you may make the following changes for yourself and eligible dependents:*






-  **Health:** Enroll in, change, or drop health plans.
-  **Vision:** Enroll in or drop State Vision plan.
-  **Optional Life:** Active employees may enroll, increase, *with medical evidence\** or cancel Optional Life.  
(\*No guaranteed issue.)
-  **Dependent Life-Spouse:** Decrease, cancel or enroll your spouse *with medical evidence.\** (\*No guaranteed issue.)
-  **Dependent Life-Child:** Enroll in or drop eligible children throughout the year.
-  **MoneyPlus:** Enroll in or **re-enroll\*** in MoneyPlus Flexible accounts. Follow this link to [2017 MoneyPlus Enrollment Form](#).

-  **SLTD:** Enroll in, *with medical evidence.\** (No guaranteed issue.)

## **NEW 2017 Plan Highlights**

-  Subscriber premiums for the State Health Plan (SHP) Standard Plan, Savings Plan and Medicare Supplemental Plan will remain the same in 2017. (Page 1)
-  Ameda manual and electric breast pumps received from a *participating provider* will be provided at no cost to pregnant subscribers and covered spouses.
-  The Prescription Drug Program’s formulary will change to *Express Scripts National Preferred Formulary*.
-  Telehealth services through “*Blue CareOnDemand*” will be a regular covered service. (Page 40)
-  The Lifetime limit for hospice service will increase to \$7,500.
