FMCSA regulation:

**§383.73 State procedures.**

(f) **License issuance.** After the State has completed the procedures described in 383.73(a), (b), (c), (d), or (e), it may issue a CDL to the driver applicant. The State shall notify the operator of the CDLIS of such issuance, transfer, renewal, or upgrade within the 10 day period beginning on the date of license issuance.

In reference to the above stated issues, I want to make you all aware of the problems with the CDL program in the Phoenix system. The problems with the system is listed below:

- When you attempt to perform a change data transaction on CDLIS in Project Phoenix the system will load invalid information into the transaction which causes the driver's not to match at CDLIS.
- Driver's who had driver's license numbers in CDLIS are now showing as customers with no driver's license number in Project Phoenix. This

is causing mismatched information at CDLIS. Change states of records or other processes cannot be performed on these drivers.

- The change state of record batch server program which updates Project Phoenix with the cdl history is not being run daily. The change state of record histories will only remain on the DHR file for 60 days and then the histories will be deleted. Some of the history records have been out there over 30 days. As of August 27, 2002, there was 154 drivers that need their driver history added. This total will increase daily.
- It was brought to my attention on August 27, 2002, that in Project Phoenix I will be added the convictions that South Carolina commercial drivers get in other states. A report of the out-of-state convictions will be generated and I will have to add the convictions into Phoenix manually. As of July 22, 2002, the report has not been ran. Angie is reviewing a report to see how many outstanding convictions need to be added.

As I continue to work with the CDL program I will keep you all aware of any further problems or delays.
