Chuck,

I hope the weekend is treating you well; I wanted to touch base with you on VPN access.

I had a brief conversation with Gary on Friday about the need to maintain access for certain ECOS staff that access the network at odd hours, mostly myself and Christian Soura; Ted Pitts is aware of the issue as well if you and Gary have concerns. I understand the merits of limiting the dissemination of access profiles, and am happy to work with Ted and Gary to limit access to appropriate staff with the understanding that sensitive files will not be distributed further. However, given the nature of our schedules, particularly during the Executive Budget process, denying access altogether is not a workable option. Given that OEPP executed this change prior to putting an alternative into place, the need to resolve this issue is immediate.

Accordingly, I am requesting that you send the token to Christian and I so that network access can be restored. We're both familiar with the process of importing the new token and using the VPN. In the interest of time, I have copied both Ted and Gary on this email. Thank you in advance for your prompt attention to this matter.
